Introduction

Headline consumer price inflation in December 2015 increased compared to the preceding month. During this period, Cambodian Riel (KHR) depreciated against US dollar while financial intermediary of the banking system in the economic activity still increased. At the same time, the international trade in goods showed a decrease in deficit.

Consumer Price Index

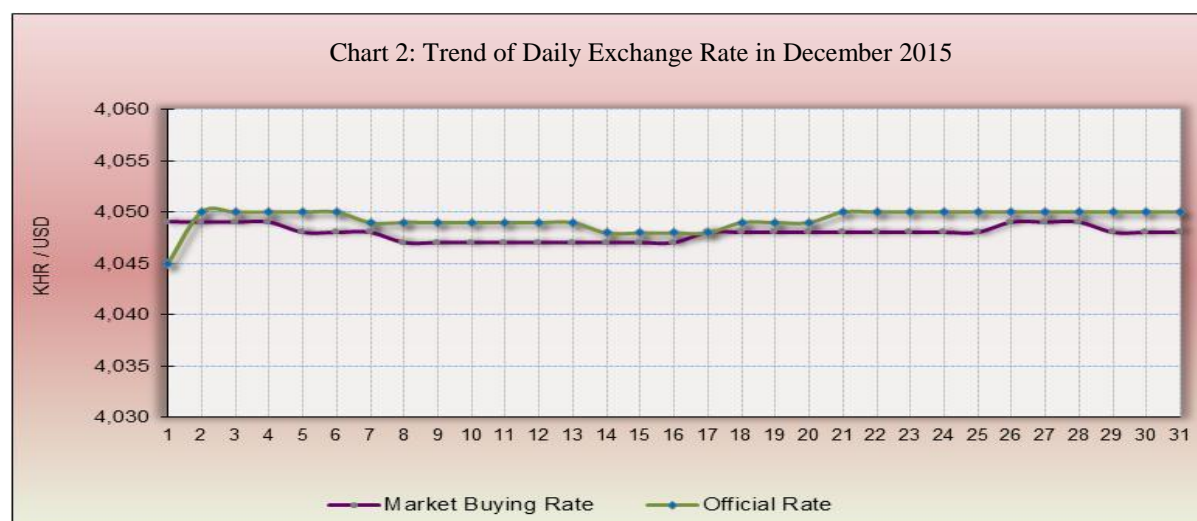
The consumer price inflation in Phnom Penh (month-on-month) accelerated to 0.17% in December 2015 after declining to the negative level of 0.2% in November 2015; in which, seven out of twelve group indexes increased while the other three group indexes decreased and two group indexes remained stable.



During the same period, the year-on-year percentage change of the CPI for all items increased to 2.85% in December from 1.92% in November 2015, reflected by the increases in prices of food, clothing, and recreation and culture while oil prices declined.

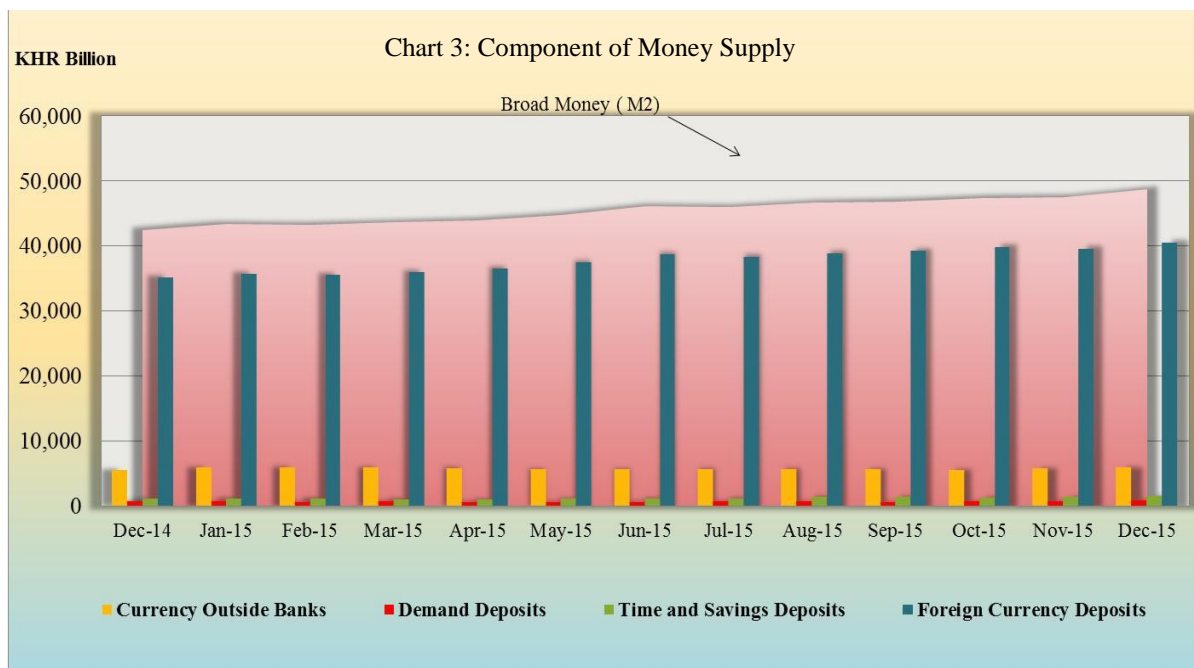
Exchange Rate

The exchange rate (market buying rate) was KHR 4,050 per US dollar in December 2015, depreciated by 0.15%, compared to the previous month.



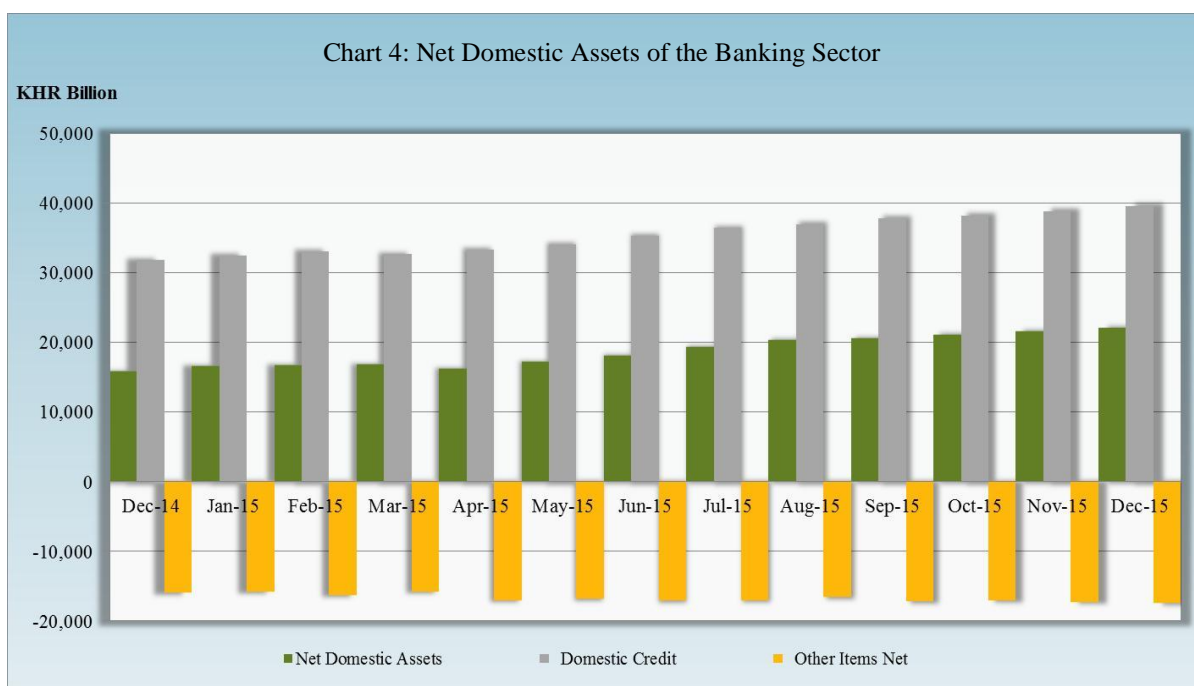
Money Supply

Broad money (M2) increased to KHR 48,823.1 billion in December 2015, up 2.7% compared to November 2015. The components of M2 contributing to the increases were time and saving deposits (11.7%), demand deposits (8.5%), currency outside banks (2.4%) and resident's foreign currency deposits (2.3%).



Net Domestic Assets of the Banking Sector

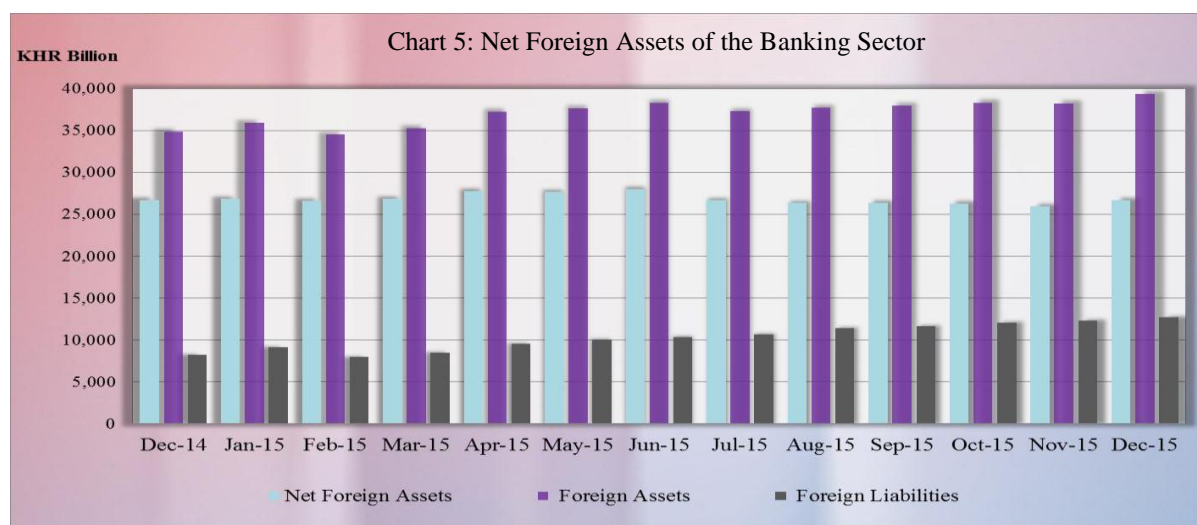
Net domestic assets of the banking sector in December 2015 continued to increase to KHR 22,157.6 billion, up 2.5% from the previous month, mainly due to an increase of 1.8% in domestic credit while other items net declined by 1%.



The increase in domestic credit was reflected by an increase of 2.1% in credit to private sector while net claims on government decreased by 3.5%.

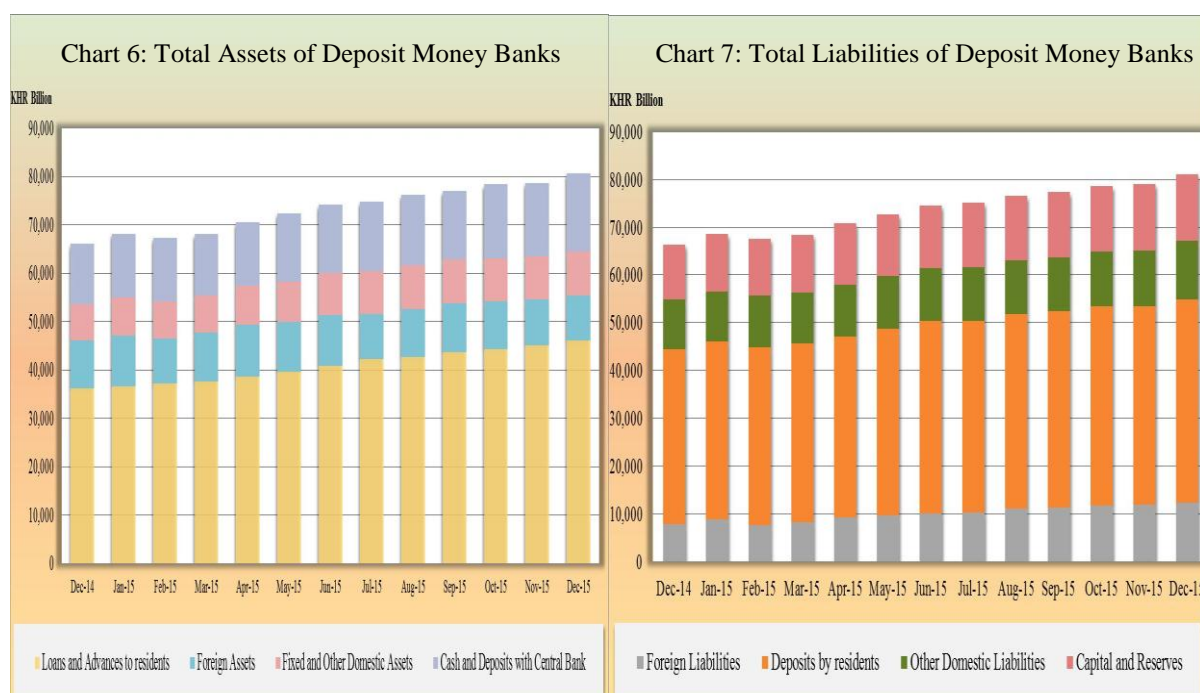
Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector increased to KHR 26,665.5 billion in December 2015, up by 2.8% from November 2015, mainly due to an increase of 2.9% in total foreign assets.



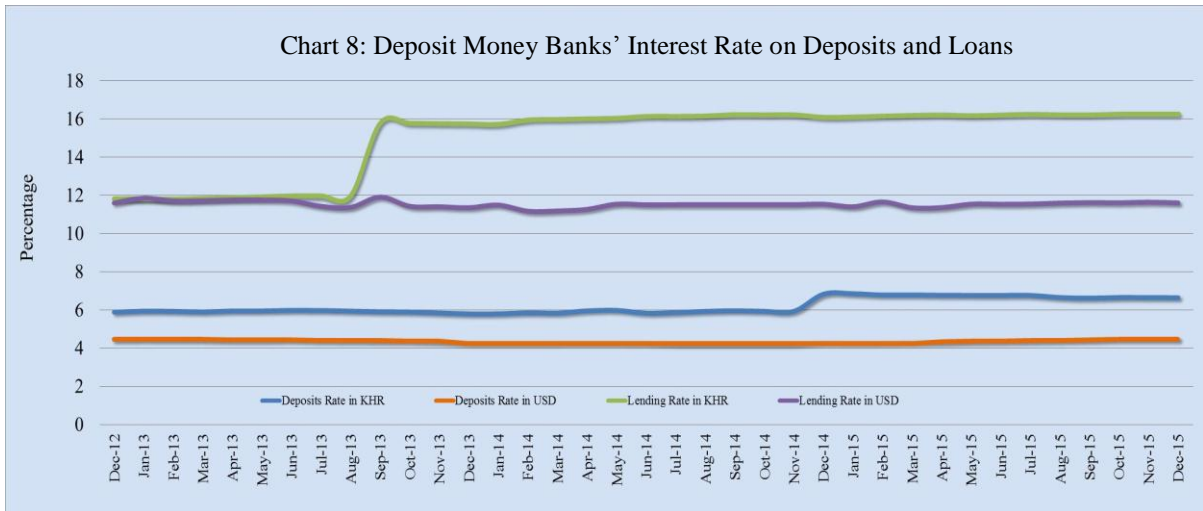
Deposit Money Banks' Operations

Total assets of commercial banks and specialized banks were KHR 80,962 billion, up by 2.5% in December 2015 from the previous month.



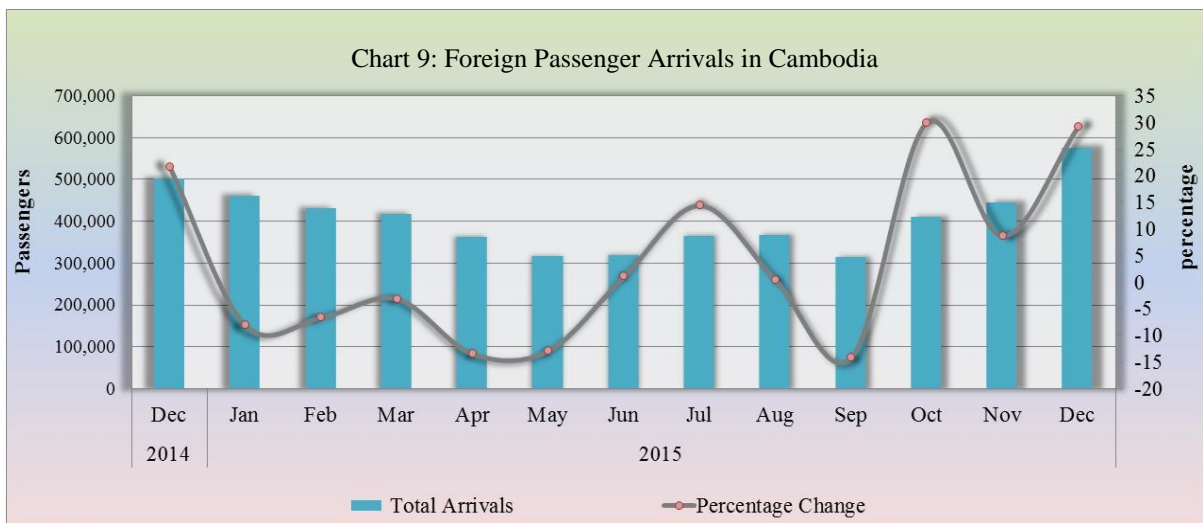
Interest Rates on Loans and Deposits

In December 2015, the interest rate movement with a 12-month maturity on deposits and loans showed that the weighted average deposit rate in KHR decreased by 0.01% and deposit in US Dollar remained stable. At the same time, the weighted average lending rate in KHR remained stable and lending rate in US dollar decreased by 0.04%.

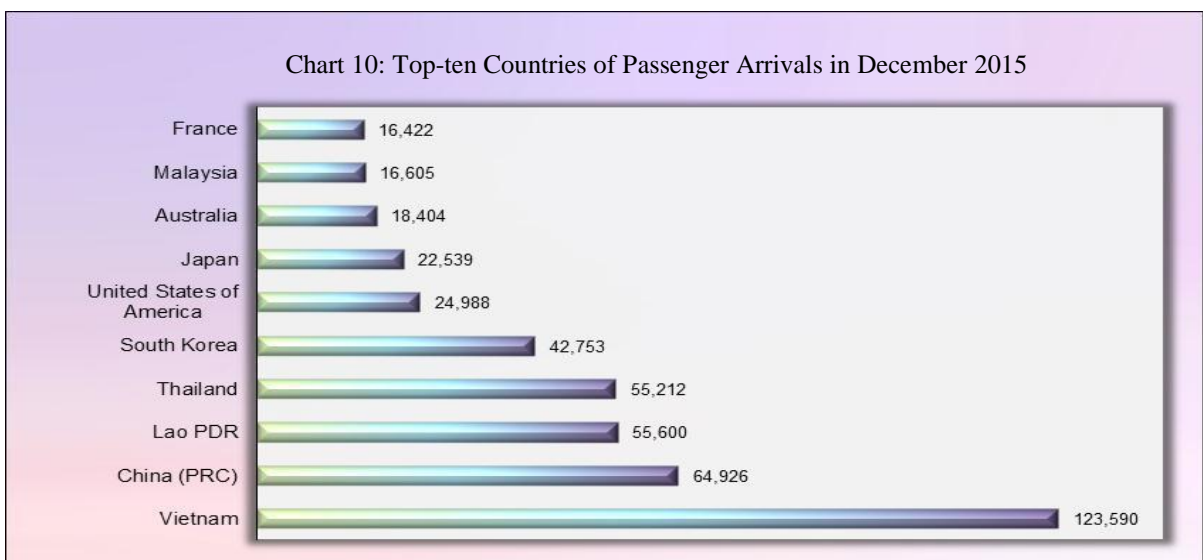


Foreign Tourist Arrivals

In December 2015, the total number of passenger arrivals was 574,799 passengers; up by 29.3% following the increase of 8.7% in the preceding month. The main purpose of the passenger arrivals in Cambodia was for vacation, accounting for more than 90% of the total.



Most of the foreign passengers were from Vietnam, China P.R.C., Lao PDR, Thailand, South Korea, United States of America, Japan, Australia, Malaysia, and France.



International Trade in Goods

International trade in goods showed a deficit of KHR 1,086.3 billion (27%) in December, from the deficit of KHR 1,143.5 billion (32.1%) in November 2015.



The major components of total exports were Garment, Footwear, Rubber, Sawn Timber, and Textile. And the major components of total imports were Petroleum, Vehicles, Gold, Motor Bikes, Construction Materials, Cigarettes, Steel, Beer, Clothing, Cloths, and Cement.

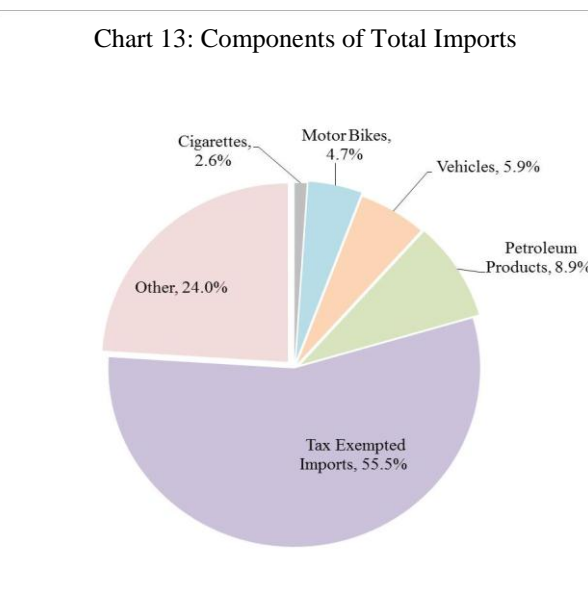
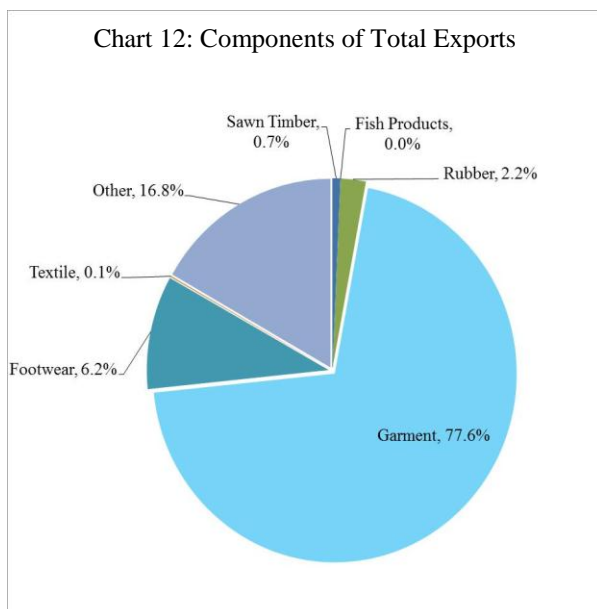

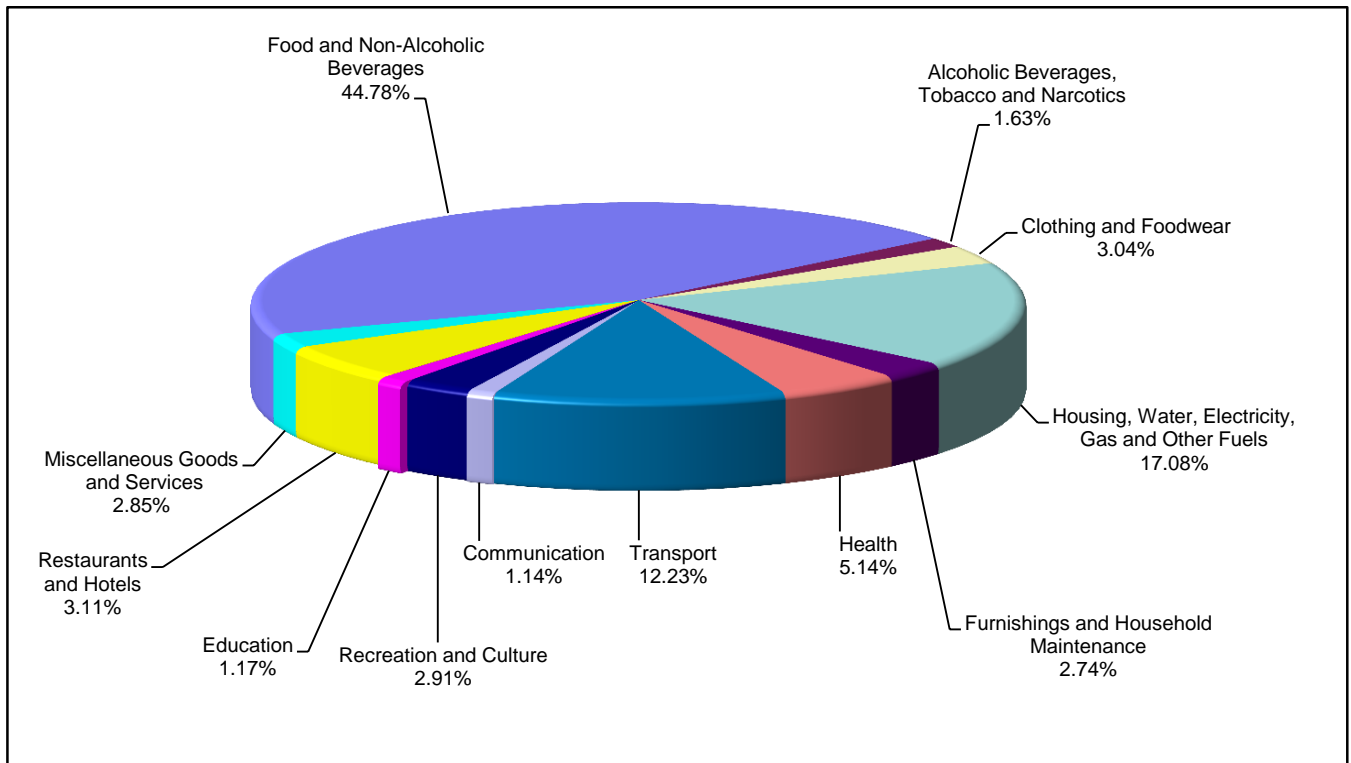

(At Constant 2000 Prices)

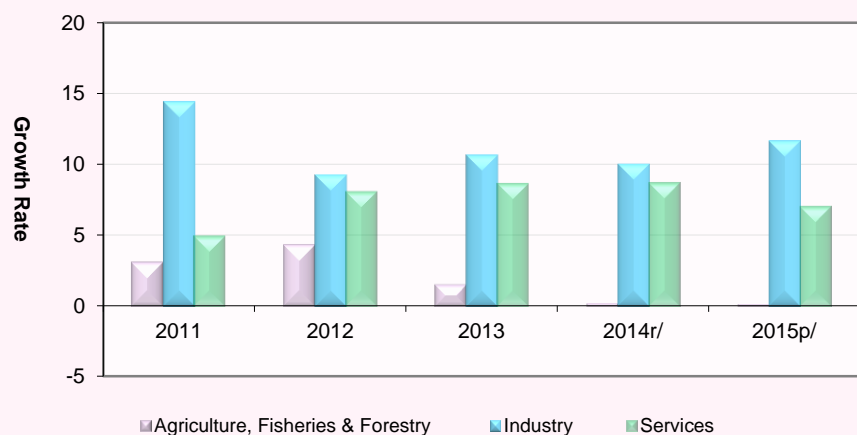
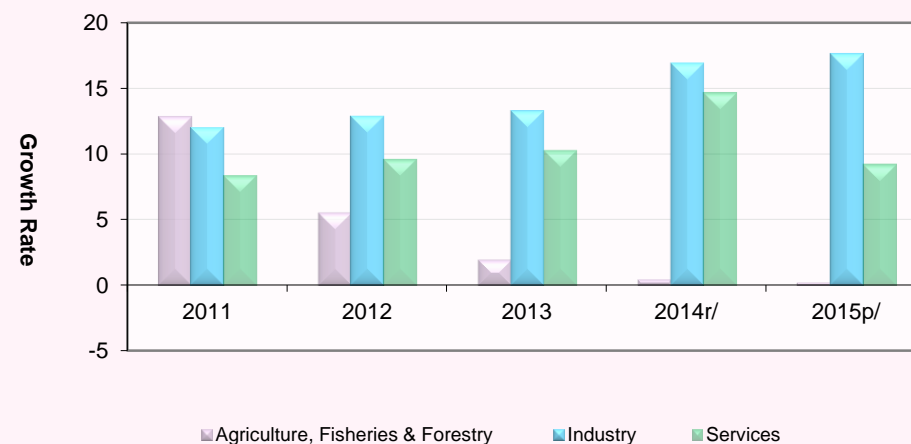


Chart 4: **GDP by Economic Activity**

Chart 5: Investment Fixed Assets by Sectors

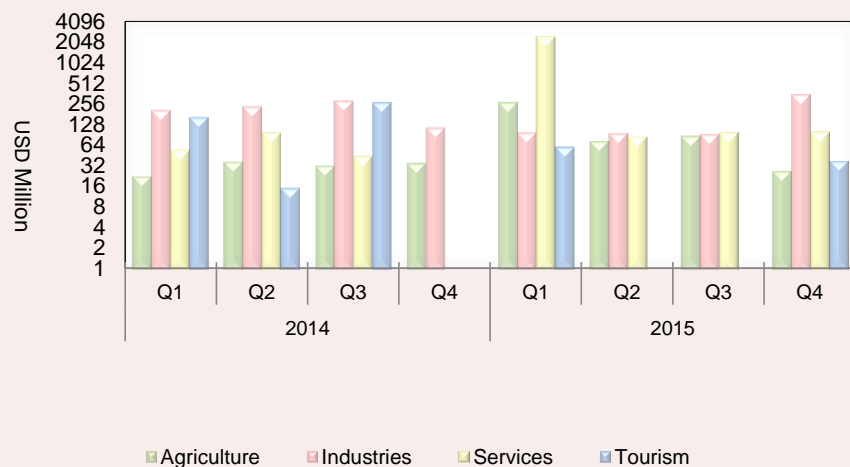
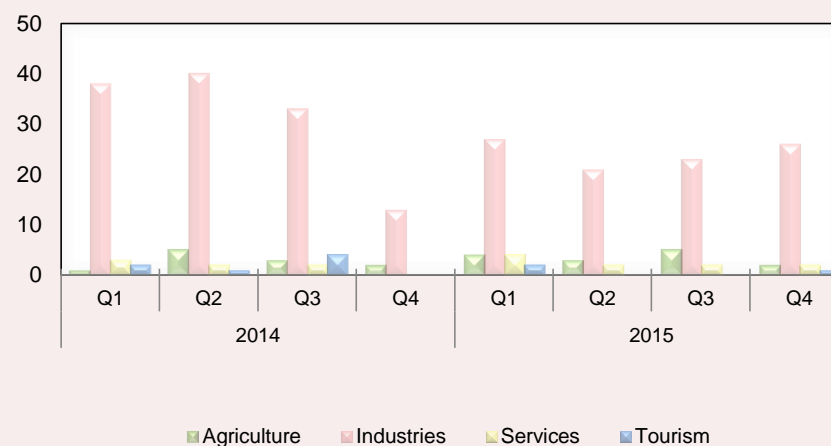


Chart 6: Number of Investment Projects by Sectors

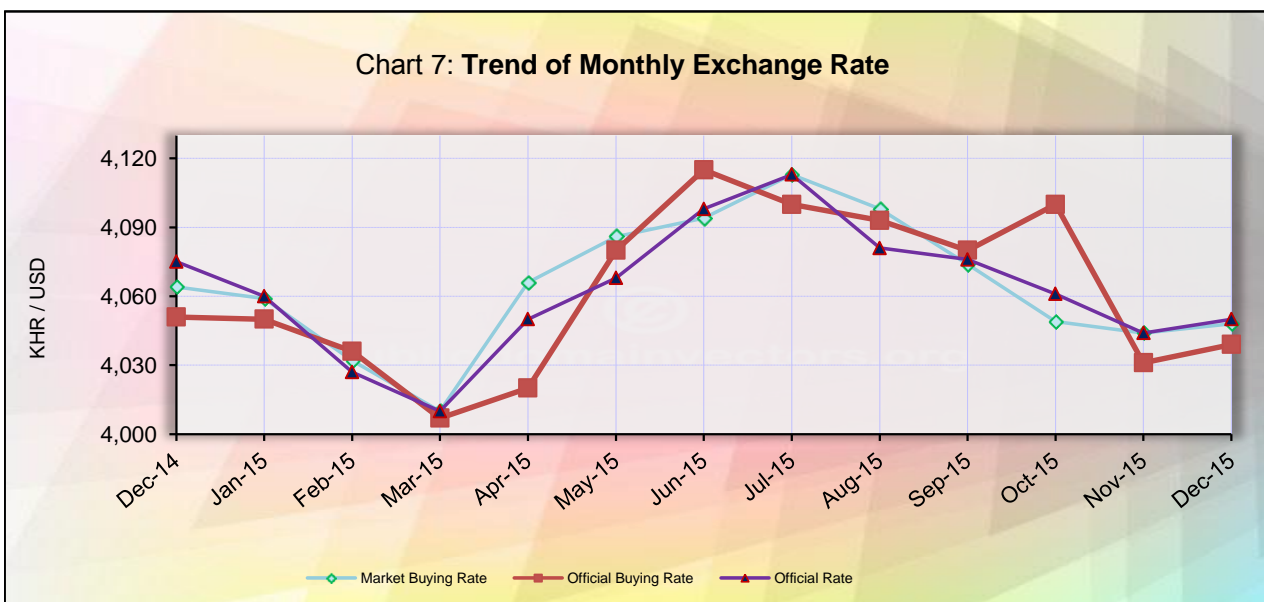

Chart 8: Monetary Survey

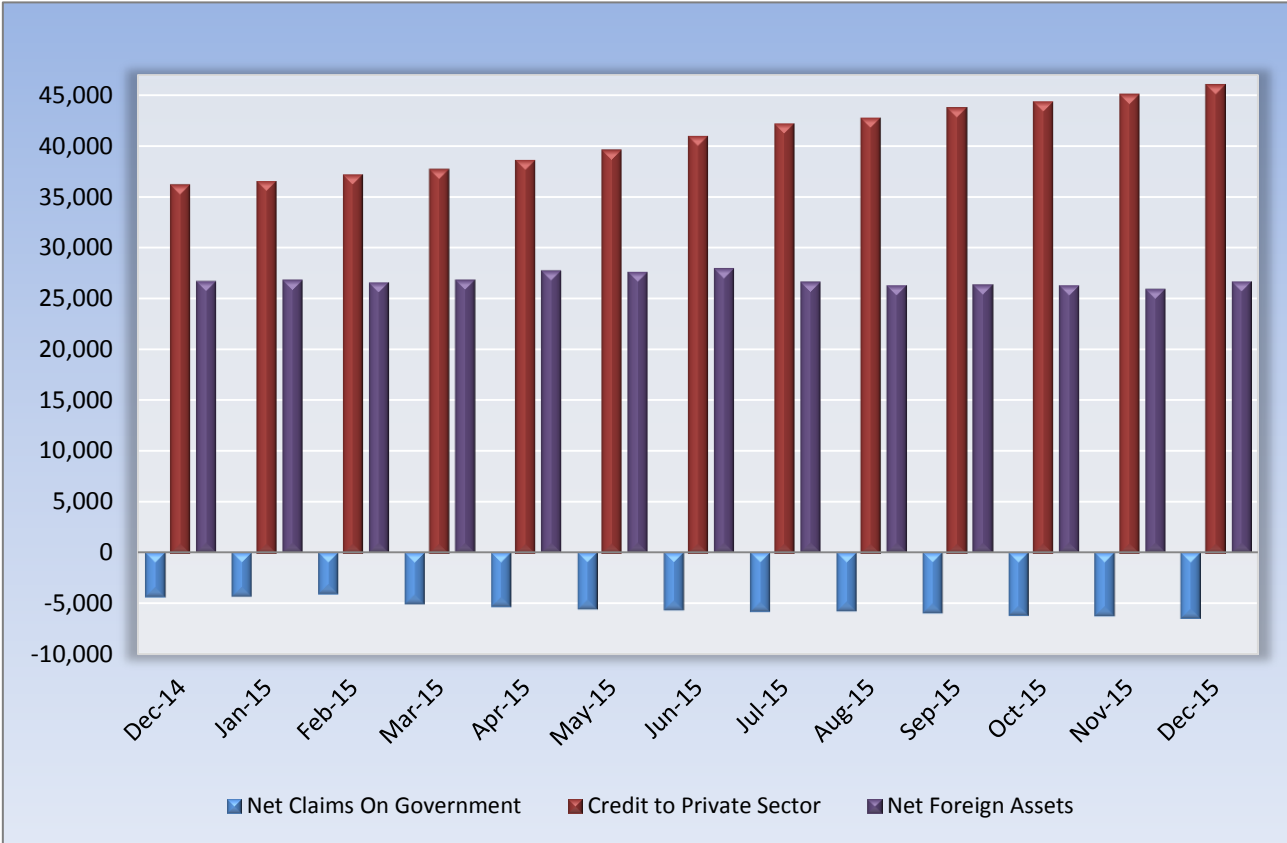


Chart 9: Components of Money Supply

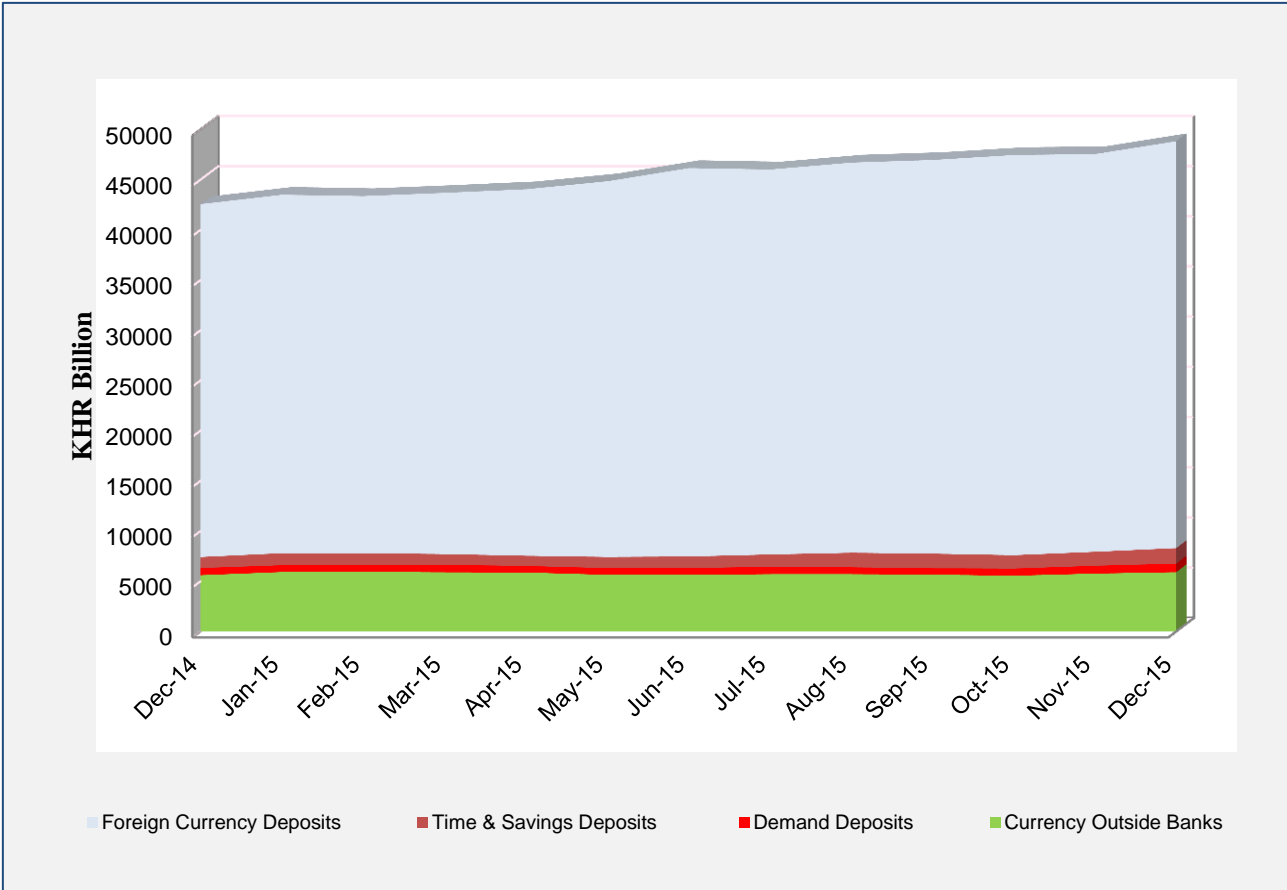

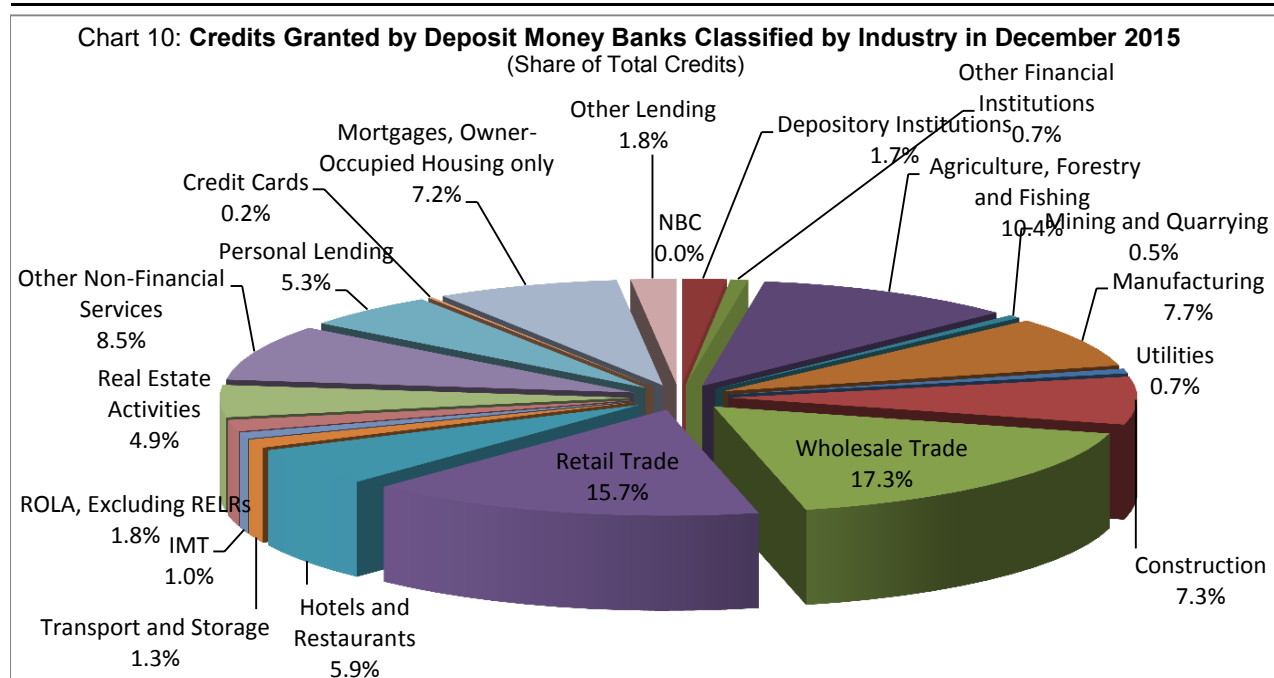

(Share of Grand Total Deposits)

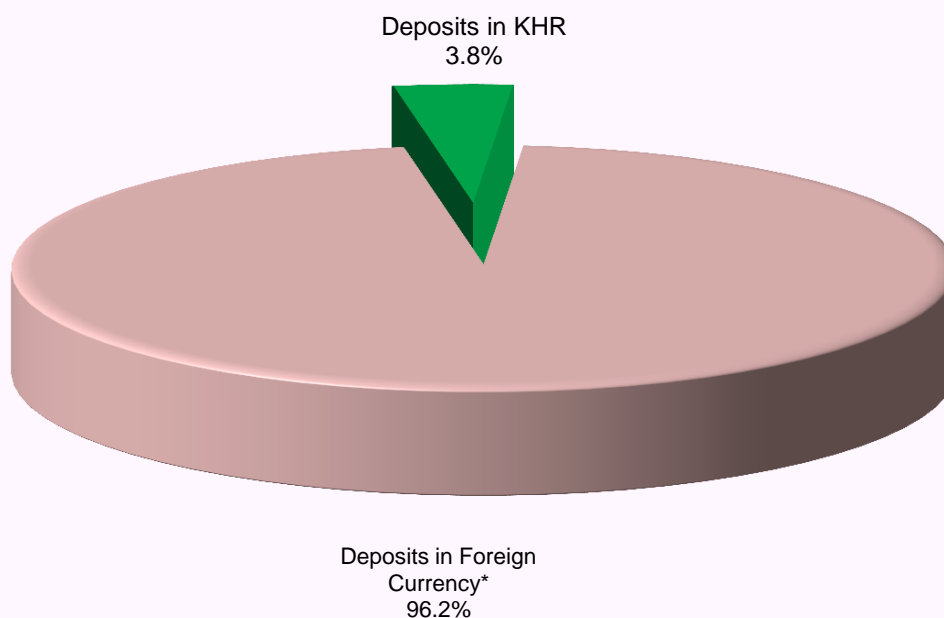

(Share of Total KHR Deposits)

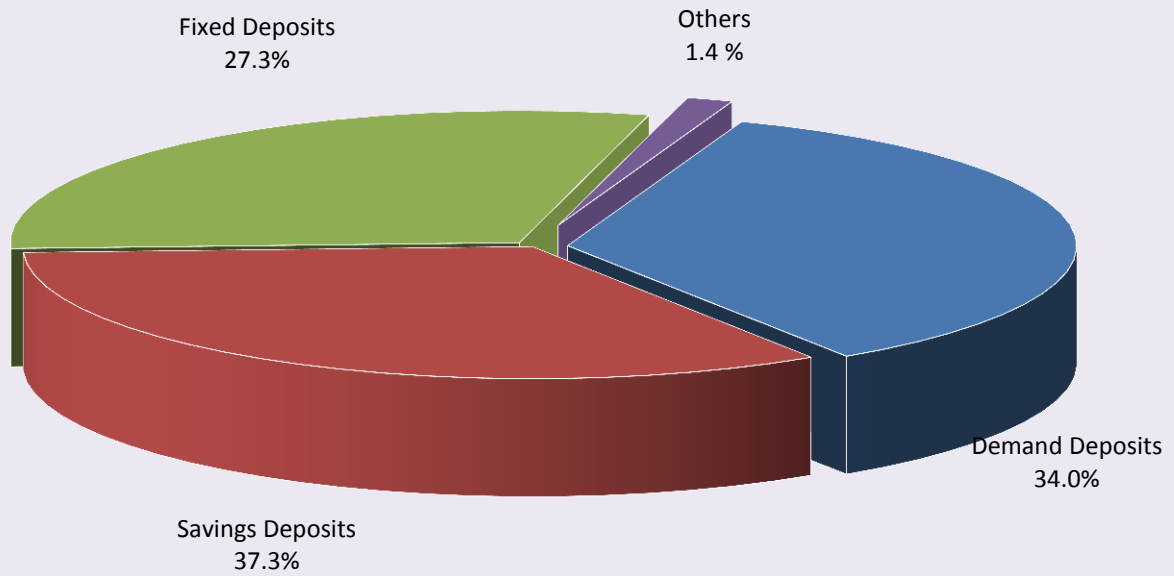
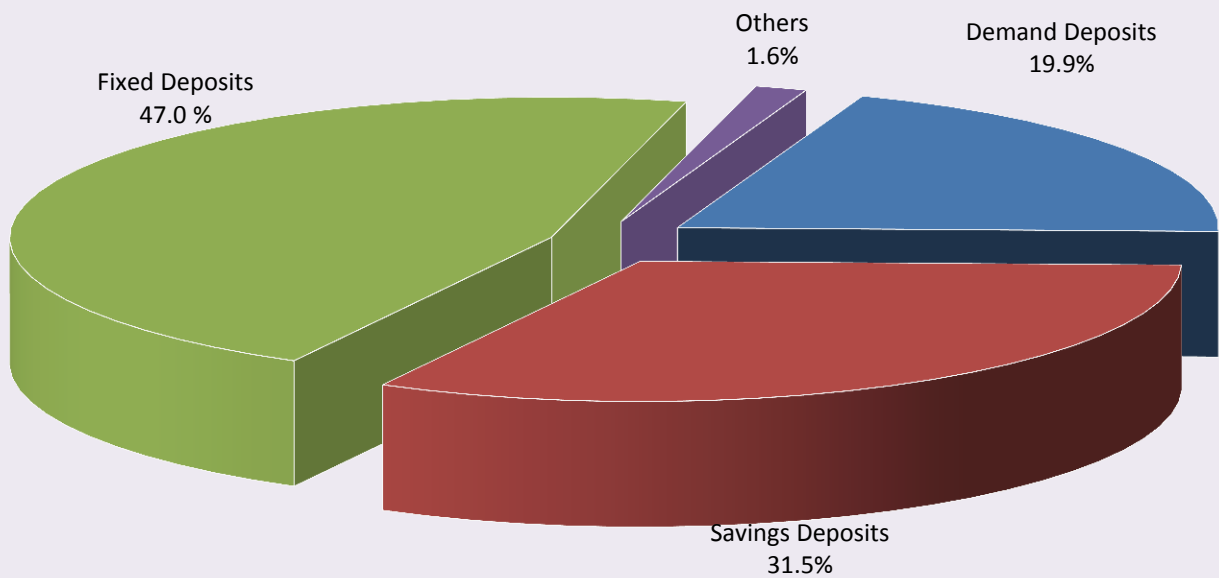


Chart 13: Deposits in Foreign Currency Classified by Type, as of December 2015
