Introduction

Headline consumer price inflation in September 2015 surged slightly compared to the preceding month. During this period, Cambodian Riel (KHR) continued to appreciate against US dollar while banking activities through credit to private sector and resident’s deposits continued to increase notably. At the same time, the international trade in goods showed an increase in deficit.

Consumer Price Index

The consumer price inflation in Phnom Penh (month-on-month) accelerated to 0.32% in September from 0.29% in August 2015. In which, six out of twelve group indexes increased while the other six group indexes decreased.



During the same period, the year-on-year percentage change of the CPI for all items increased to 0.94% in September from 0.80% in August 2015, reflected by the increase in prices of food and clothing while oil price decreased.

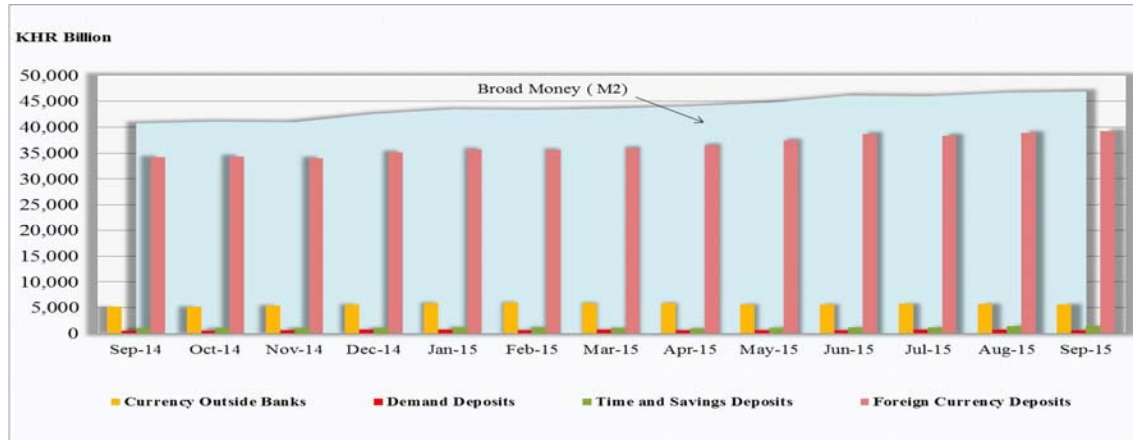
Exchange Rate

The exchange rate (market buying rate) was KHR 4,074 per US dollar in September 2015, appreciated by 0.59%, compared to the previous month. This was due to the increases in demand for KHR for tax payment purpose and for spending during the Pchum Ben day.



Money Supply

Broad money (M2) increased moderately to KHR 46,960.1 billion in September 2015, up 0.6% compared to August 2015. The components of M2 including resident's foreign currency deposits and time and saving deposits increased by 0.9% and 0.1%, respectively. Demand deposits and currency outside banks decreased by 6.4% and 0.9%, respectively.



Net Domestic Assets of the Banking Sector

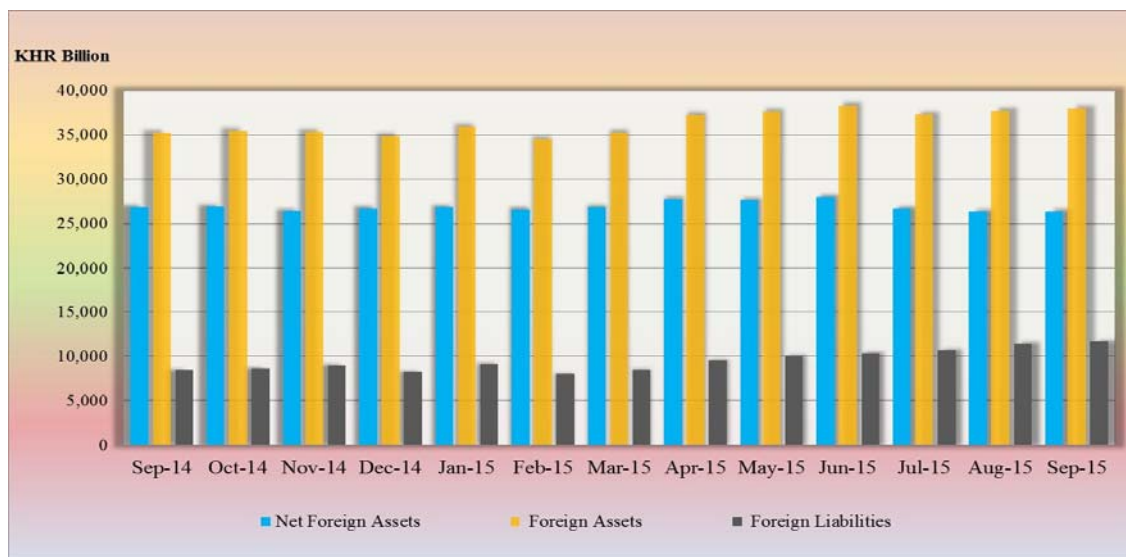
Net domestic assets of the banking sector in September 2015 continued to increase to KHR 20,600.9 billion, up 1% from the previous month, due to an increase of 2.2% in domestic credit while other items net declined by 3.7%.



The increase in domestic credit was reflected by an increase of 2.3% in credit to private sectors while net claims on government decreased by 3.2%.

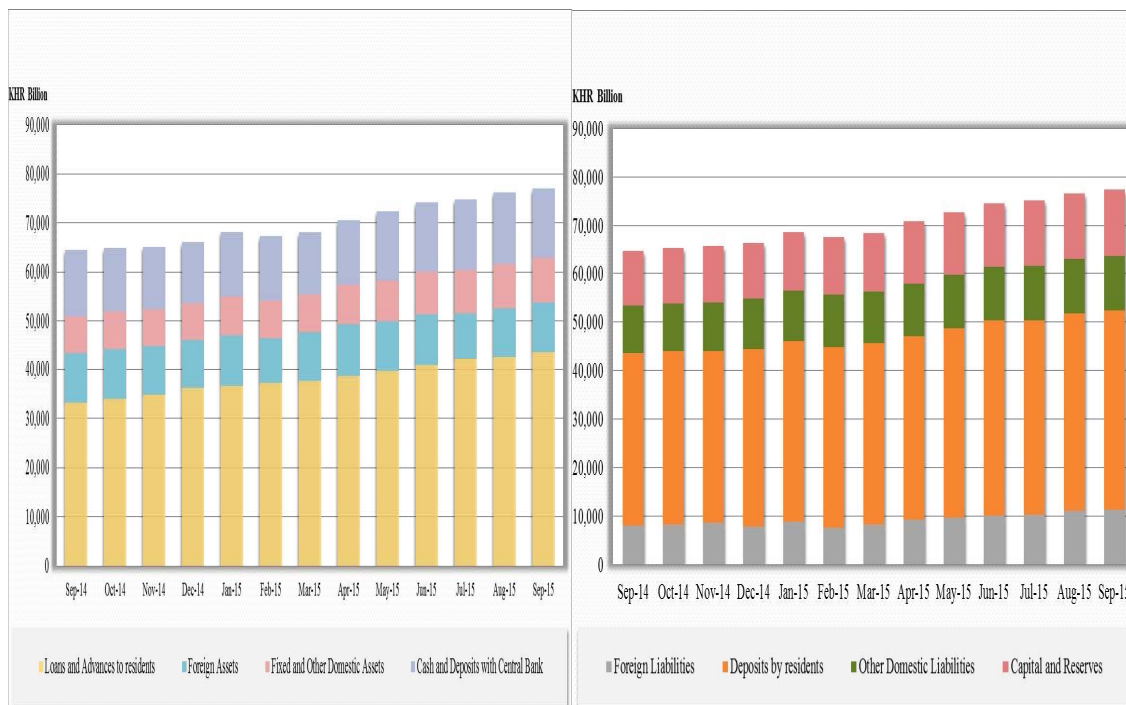
Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector increased to KHR 26,359.2 billion in September 2015, up by 0.2% from August 2015, mainly due to an increase of 0.7% in total foreign assets.



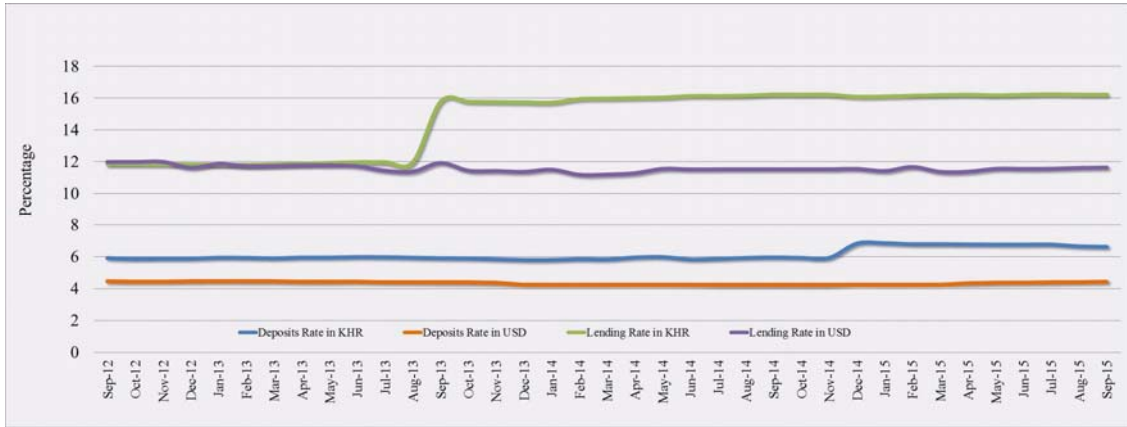
Deposit Money Banks' Operations

Total assets of commercial banks and specialized banks were KHR 77,219.4 billion, up by 1% in September 2015 from the previous month.



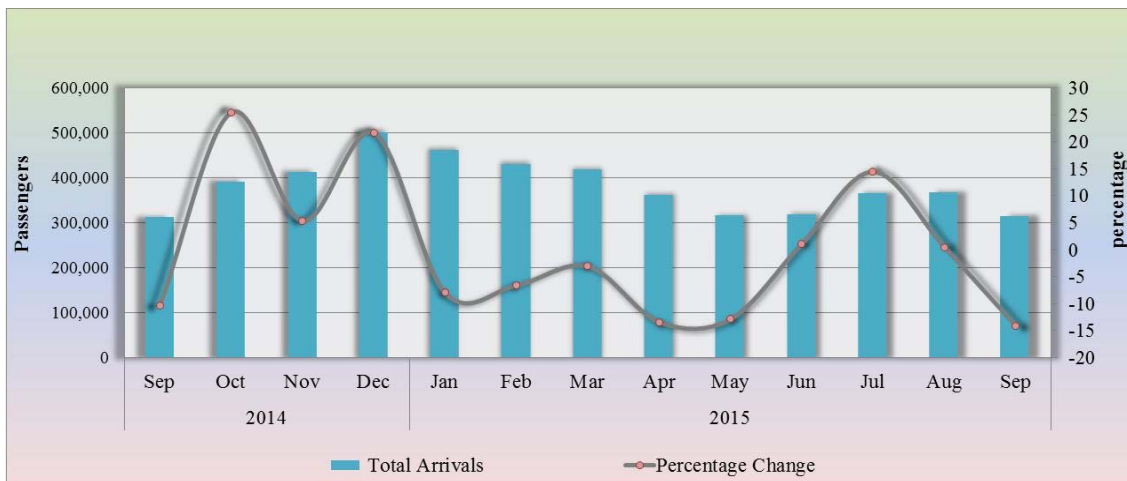
Interest Rates on Loans and Deposits

In September 2015, the interest rate movement of 12-months maturity loans and deposits showed that the weighted average deposit rate in KHR decreased by 0.03% while deposit in US Dollar increased by 0.02%. At the same time, the weighted average lending rate in KHR remained stable at 16.20% as in August 2015 while lending rate in US dollar decreased slightly by 0.01%.

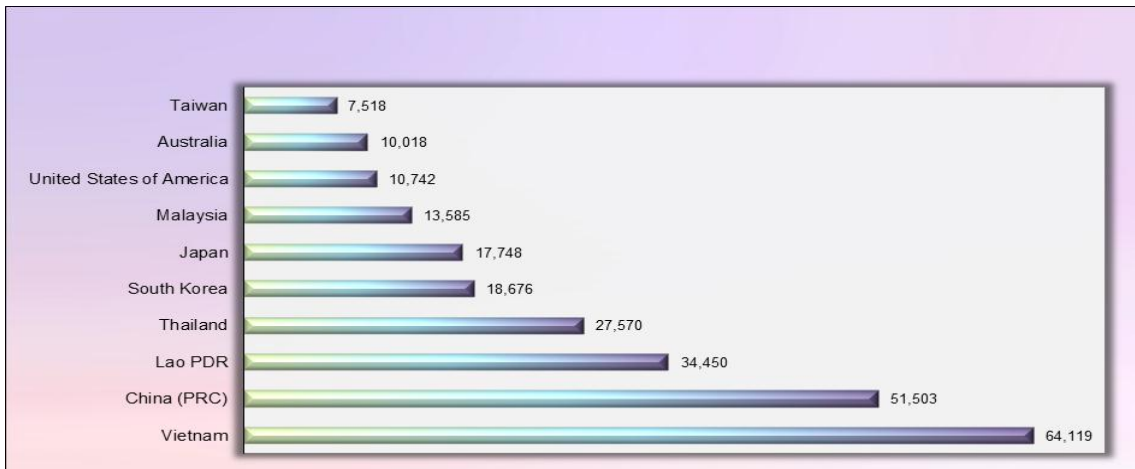


Foreign Tourist Arrivals

In September 2015, the total number of passenger arrivals was 314,459 passengers; down by 14.1% after increasing 0.5% last month. The main purpose of the passenger arrivals in Cambodia was for vacation, accounting for more than 88% of the total.



Most of the foreign passengers were from Vietnam, China P.R.C., Lao PDR, Thailand, South Korea, Japan, Malaysia, United States of America, Australia and Taiwan.



International Trade in Goods

International trade in goods showed a deficit of KHR 921.7 billion (25.4%) in September, from the deficit of KHR 824 billion (21.2%) in August 2015.



The major components of total exports were Garment, Footwear, Rubber, and Textile. And the major components of total imports were Petroleum, Vehicles, Steel, Gold, Motor Bikes, Construction Materials, Cigarettes, Cement, Clothing, Beer, and Cloths.

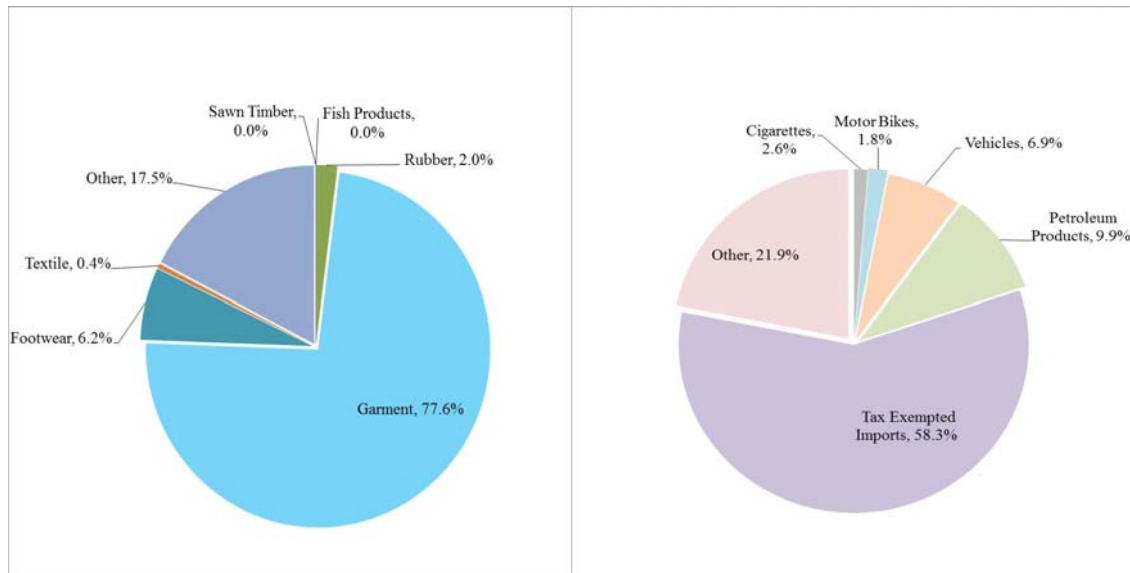

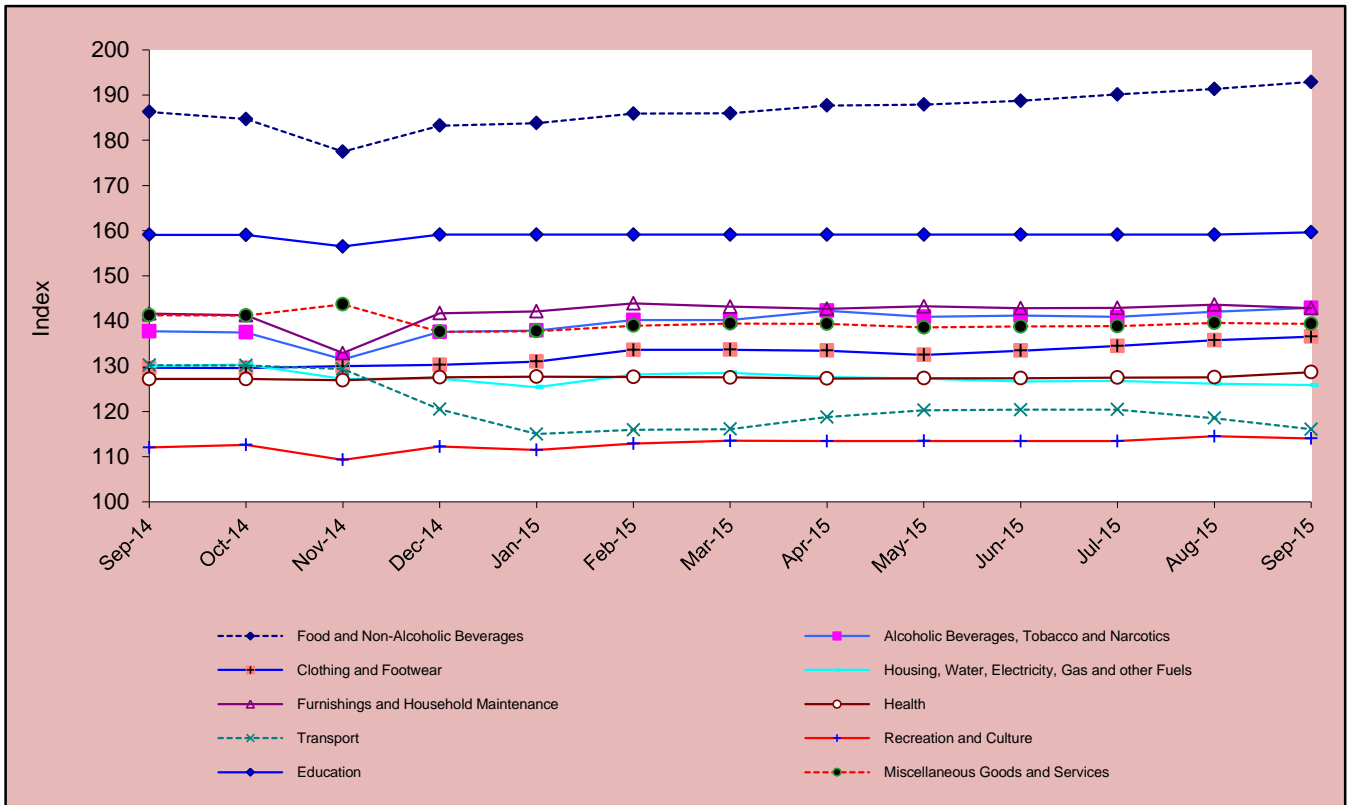

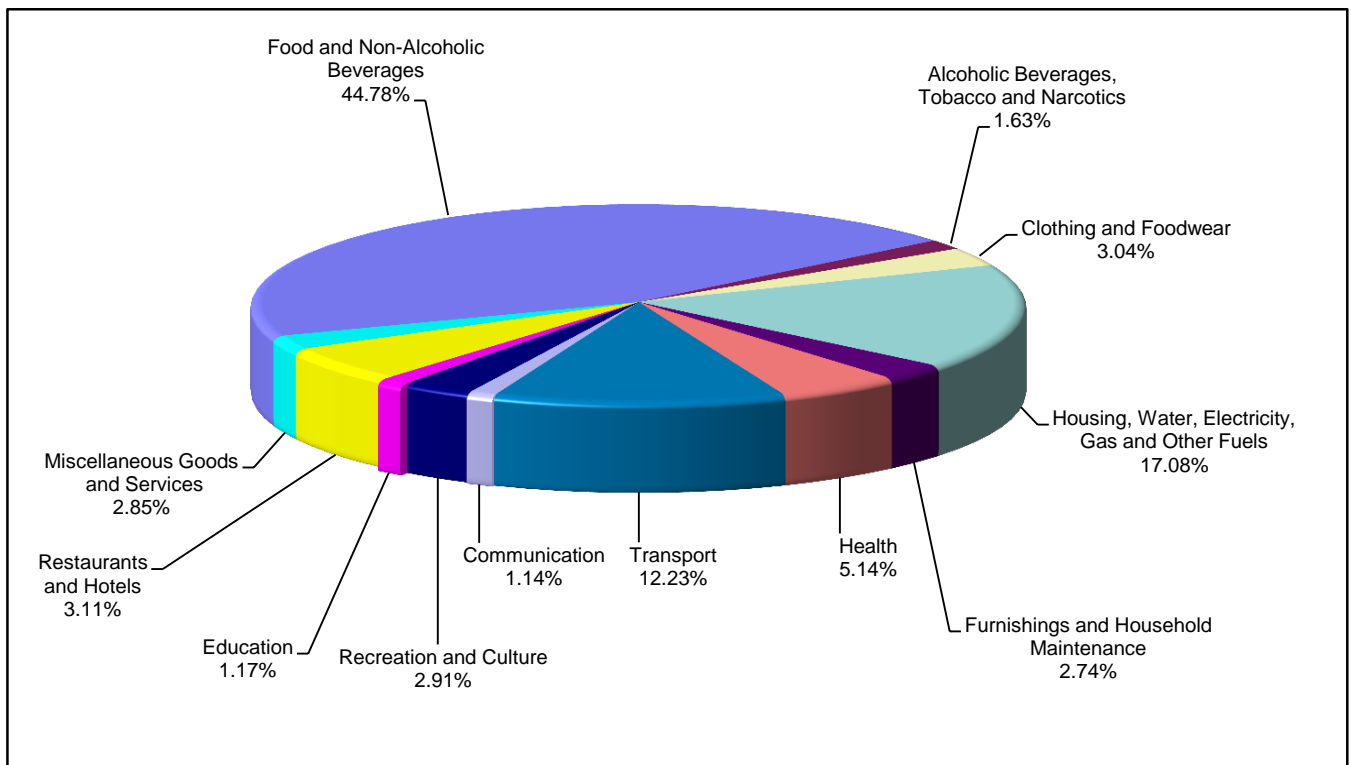

(At Constant 2000 Prices)

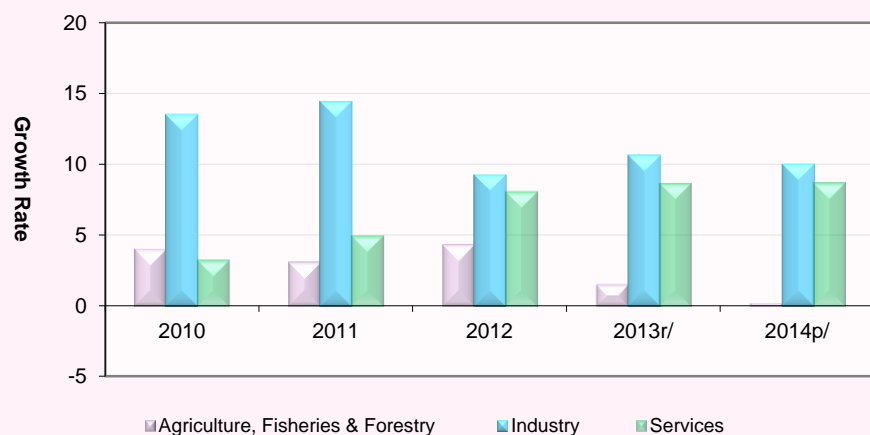
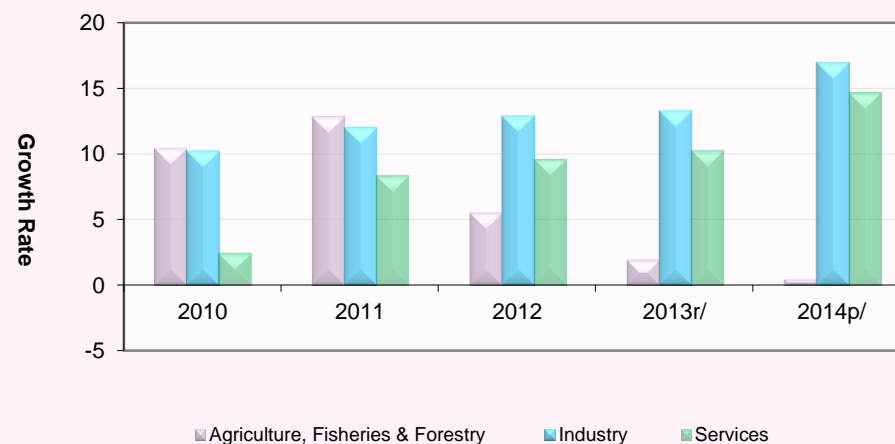


Chart 4: **GDP by Economic Activity**

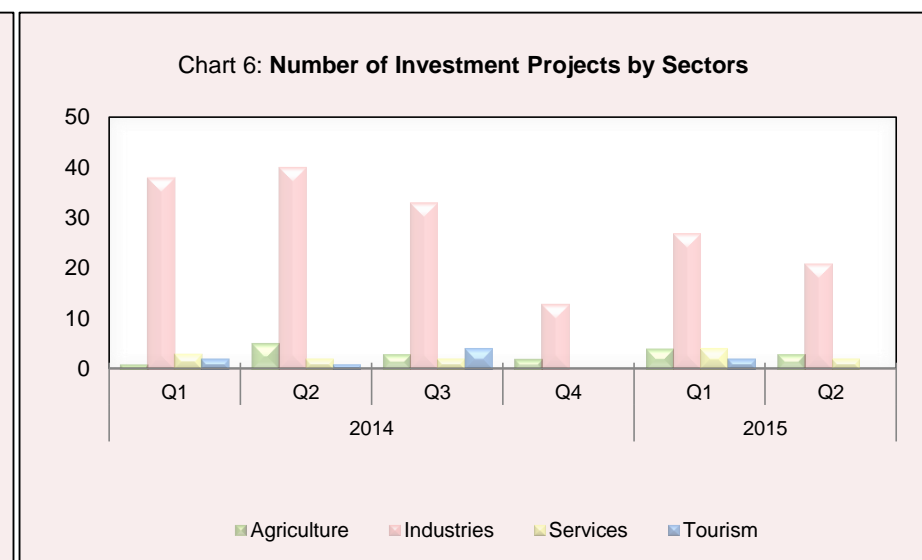
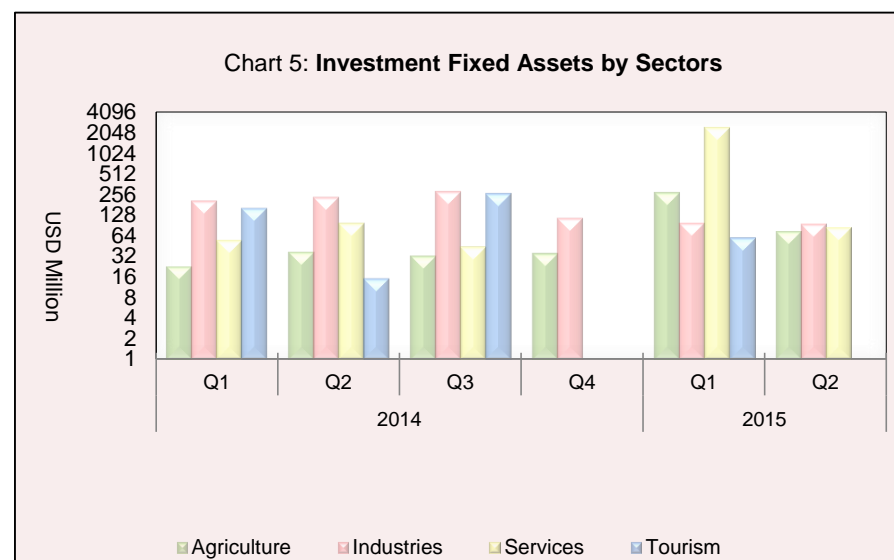

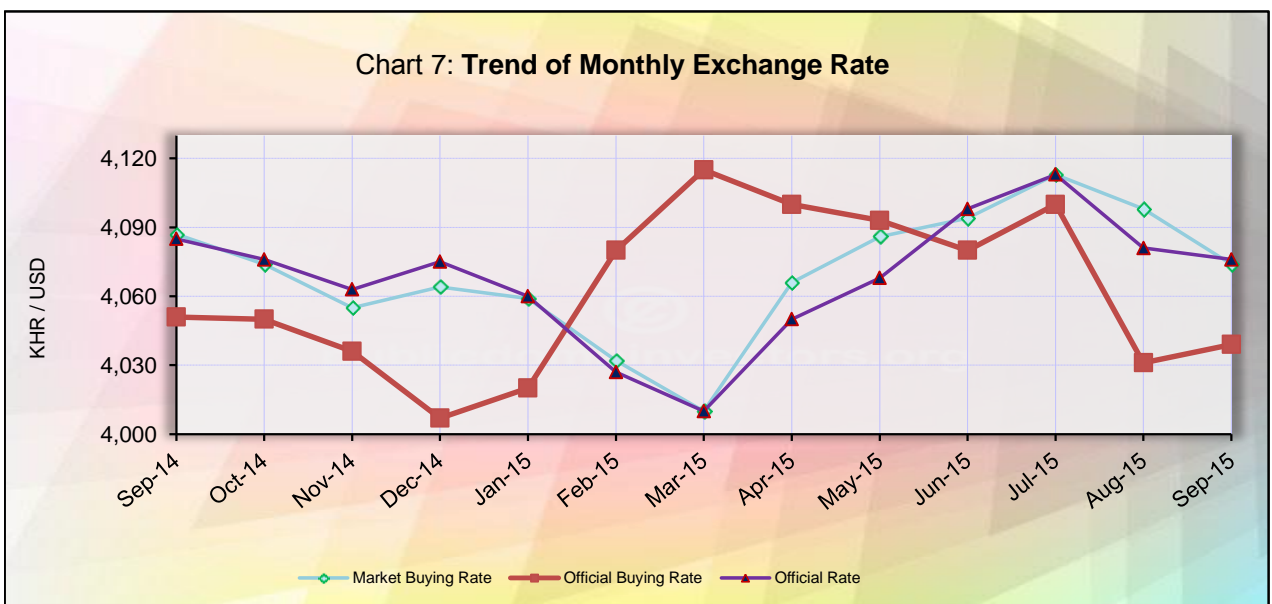

Chart 8: Monetary Survey

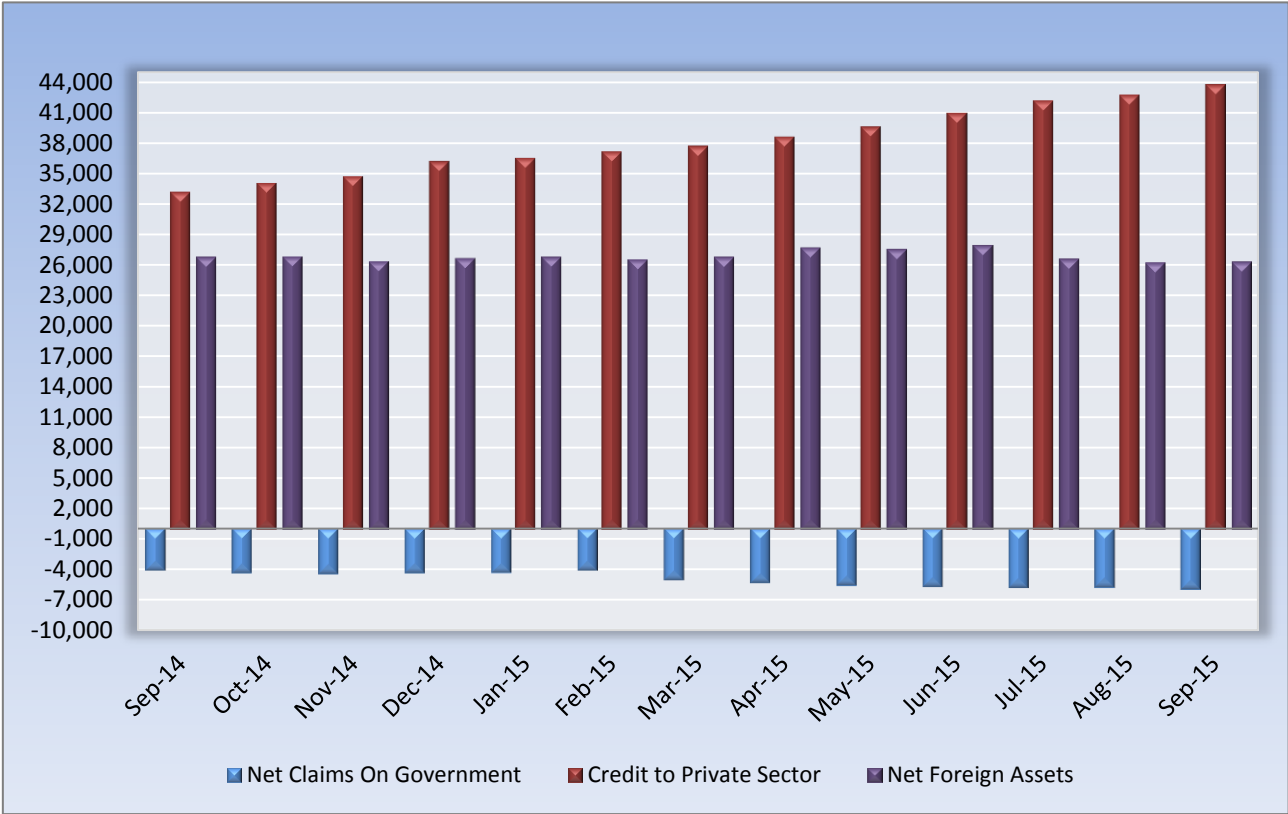


Chart 9: Components of Money Supply

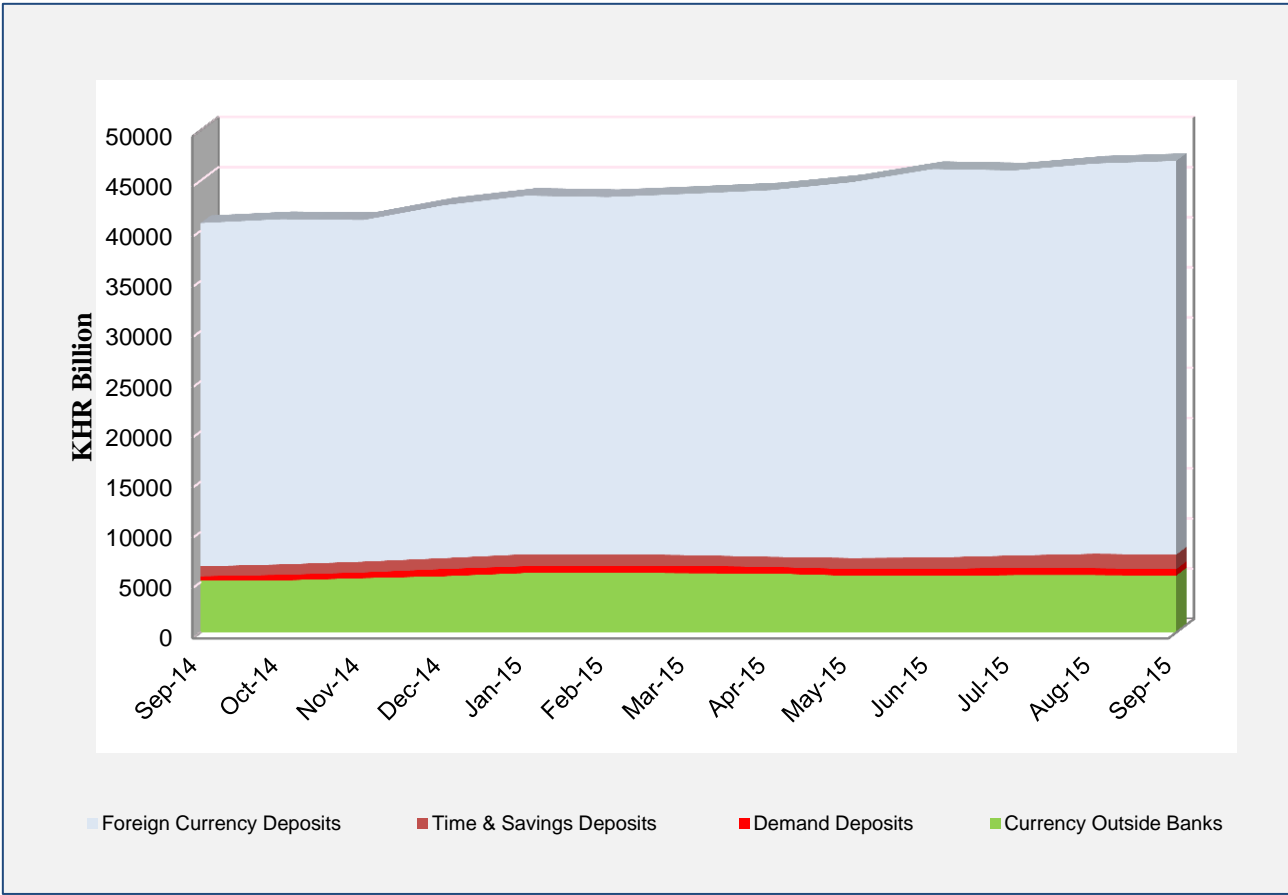

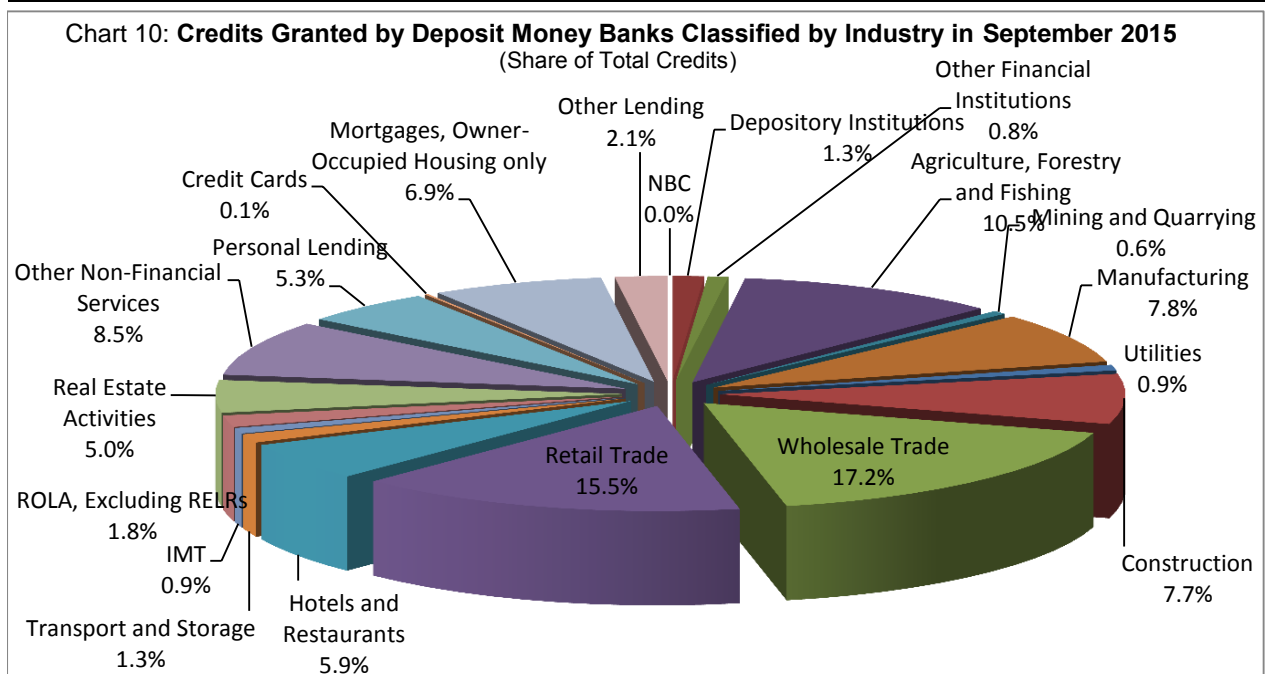

(Share of Grand Total Deposits)

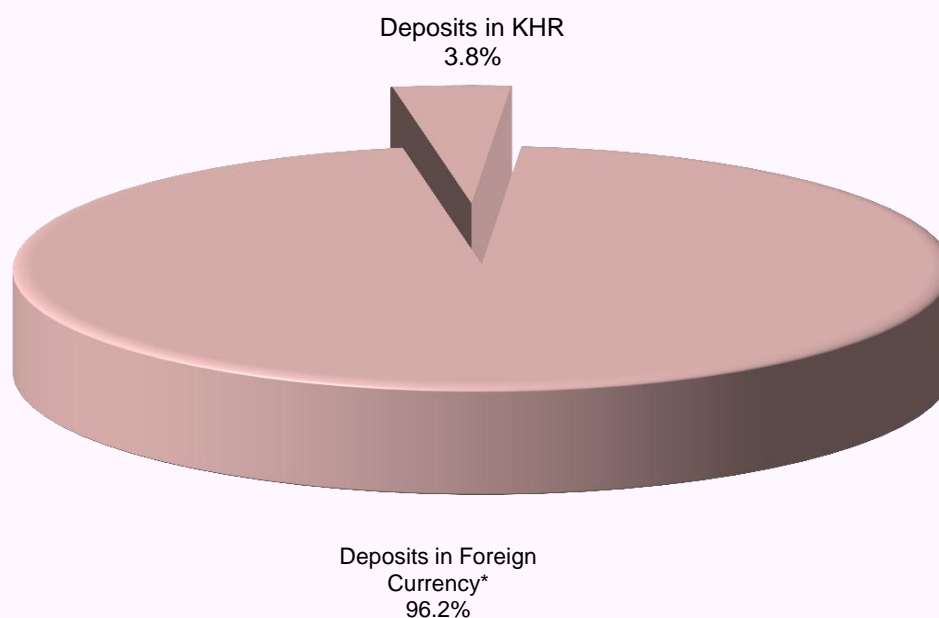

(Share of Total KHR Deposits)

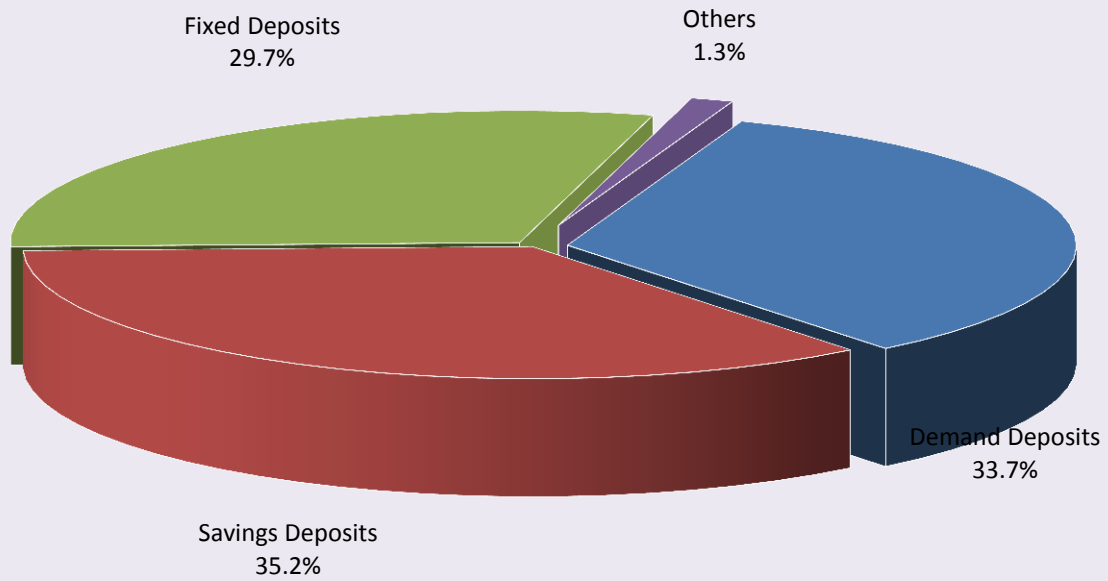
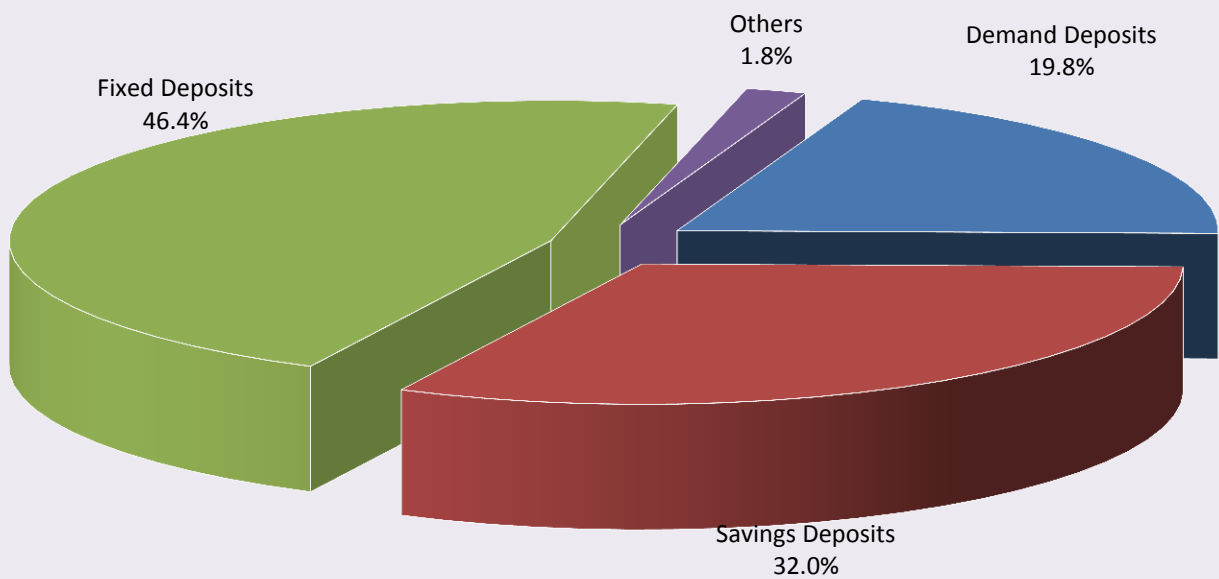


Chart 13: Deposits in Foreign Currency Classified by Type, as of September 2015
