Introduction

Headline consumer price inflation in February 2016 accelerated compared to January. During this period, Cambodian Riel (KHR) continued to appreciate against US dollar while financial intermediary of the banking system continued to improve. At the same time, the international trade in goods showed a decrease in deficit.

Consumer Price Index

The consumer price inflation in Phnom Penh (month-on-month) increased to 0.44% in February 2016 after declining to the negative level of 0.24% in January. In which, six out of twelve group indexes increased while the other four group indexes decreased and two group indexes remained stable.



During the same period, the year-on-year percentage change of the CPI for all items decreased to 2.31% in February 2016 from 3.05% in January 2016, reflected by the decrease in oil prices contributed with the lower hike in food prices.

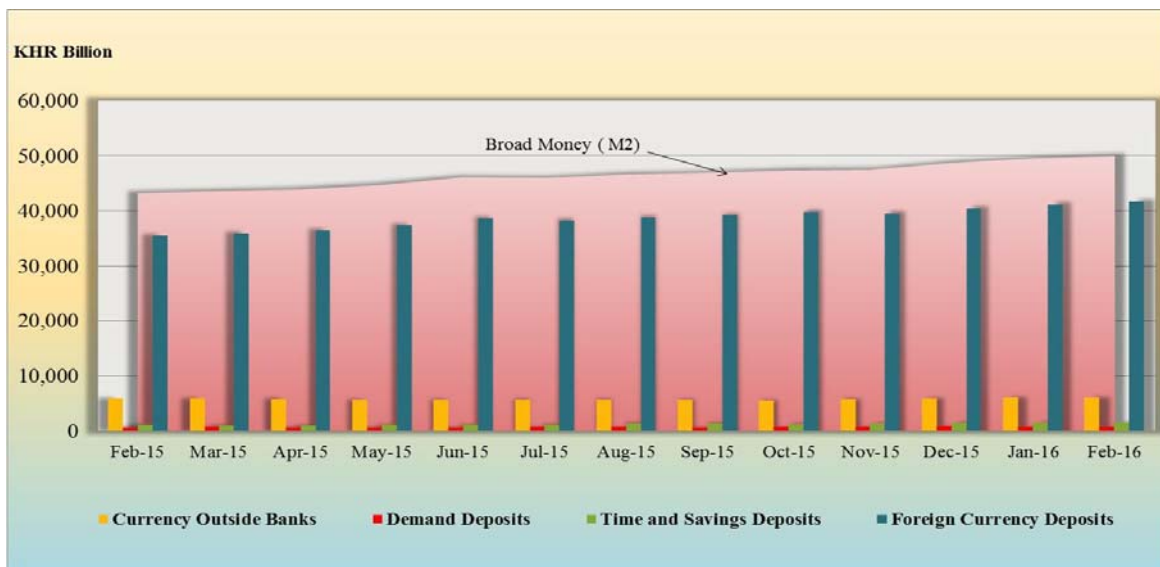
Exchange Rate

The exchange rate (market buying rate) was KHR 4,010 per US dollar in February 2016, appreciated by 0.67%, compared to the previous month. This was mainly due to the increase in KHR demand for tax payment purpose and other spending during the Chinese New Year.



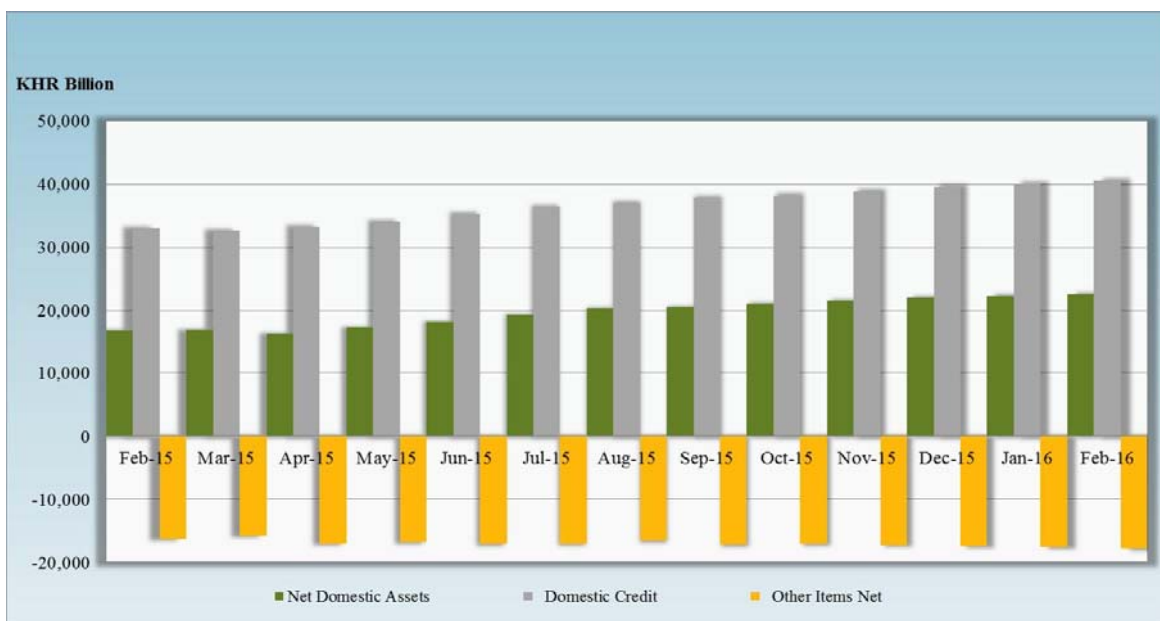
Money Supply

Broad money (M2) increased to KHR 50,037.2 billion in February 2016, up 0.9% compared to January. The components of M2 including resident's foreign currency deposits, time and saving deposits, and currency outside banks, increased by 1.1%, 0.4%, and 0.3%, respectively while demand deposit declined by 3.3%.



Net Domestic Assets of the Banking Sector

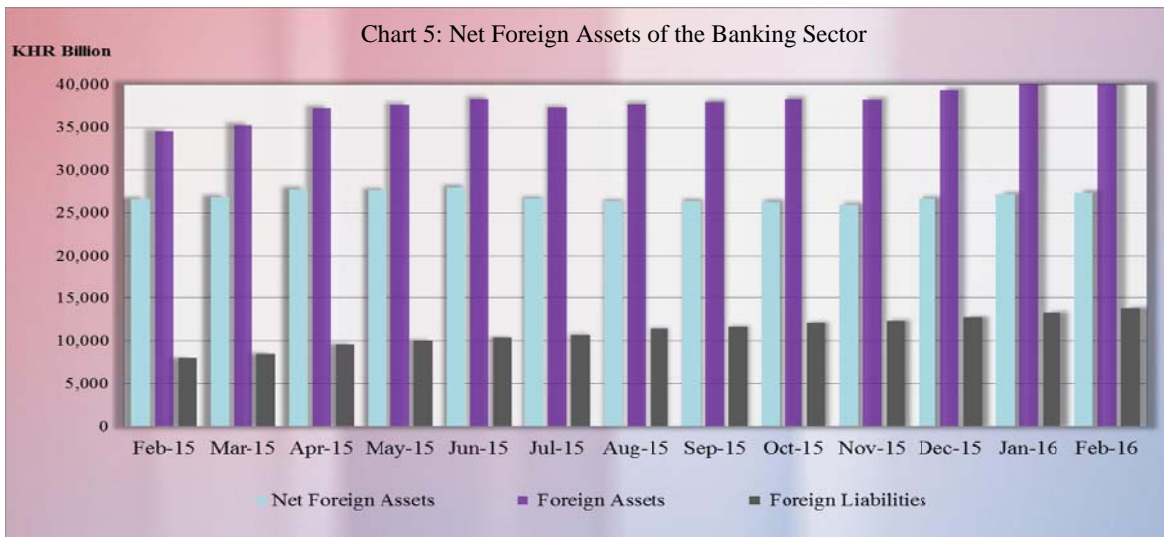
Net domestic assets of the banking sector in February 2016 continued to increase to KHR 22,695.7 billion, up 1.1% from the previous month, mainly due to an increase of 1.3% in domestic credit while other items net declined by 1.4%.



The increase in domestic credit was reflected by an increase of 1.2% in credit to private sectors while net claims on government declined by 1.2%.

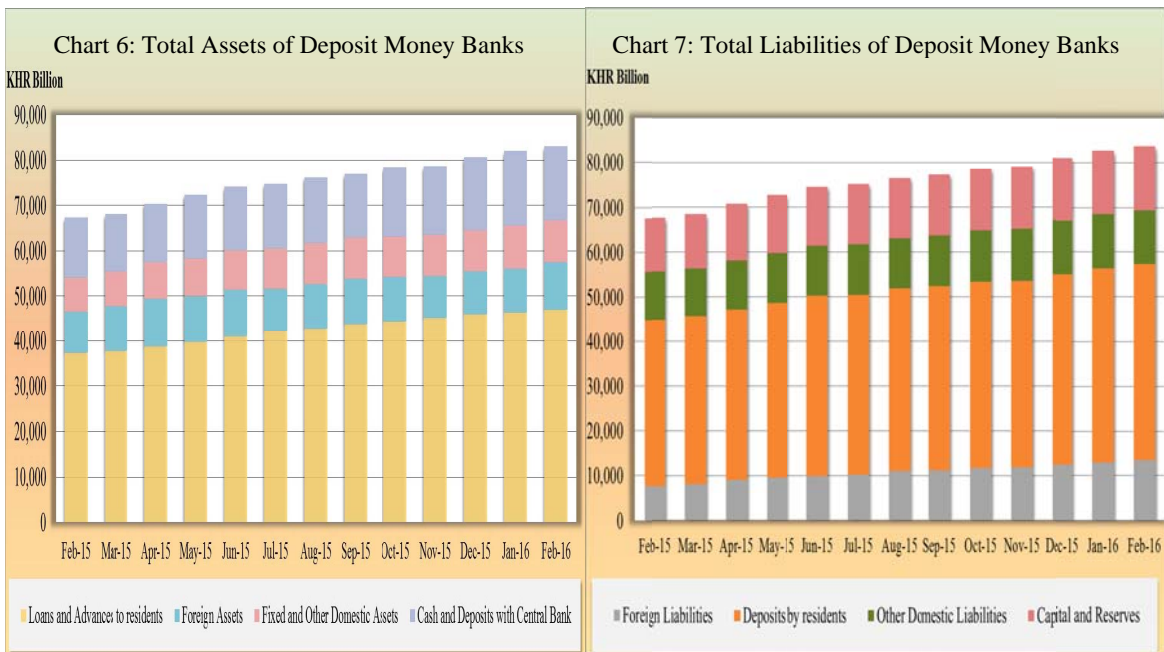
Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector increased to KHR 27,341.5 billion in February 2016, up by 0.8% from January, mainly due to an increase of 1.8% in total foreign assets.



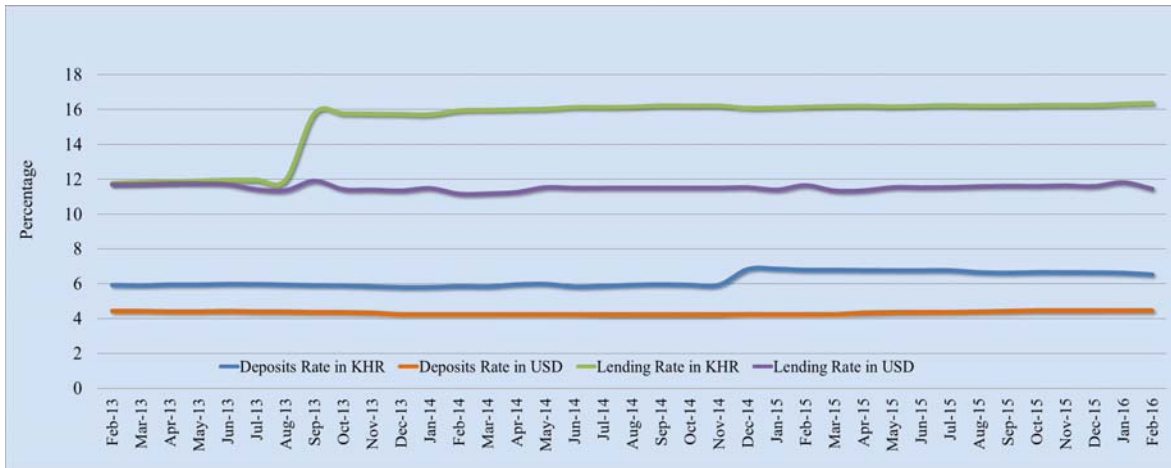
Deposit Money Banks' Operations

Total assets of commercial banks and specialized banks were KHR 83,560.9 billion, up by 1.2% in February 2016 from the previous month.



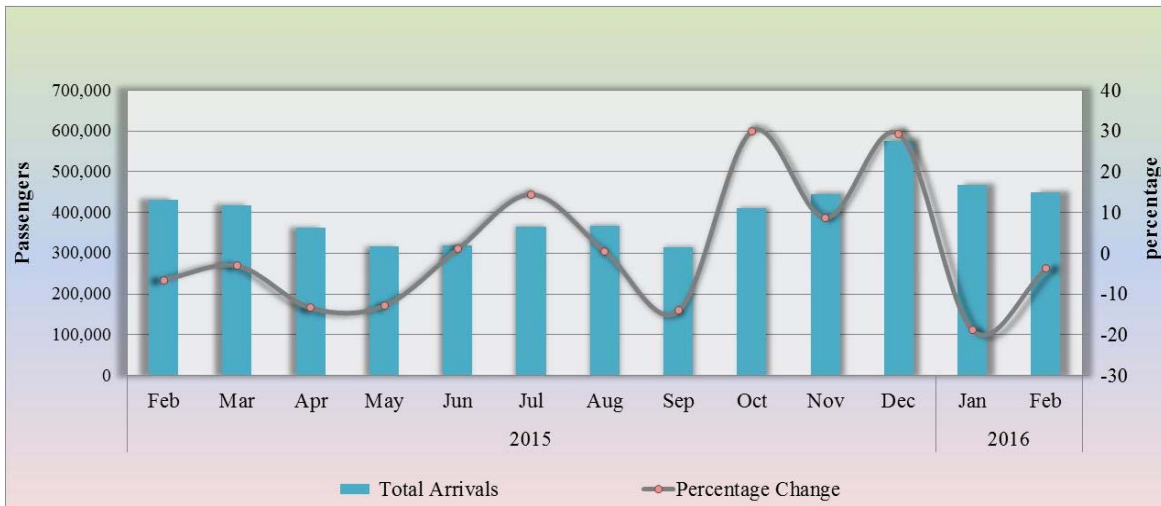
Interest Rates on Loans and Deposits

In February 2016, the interest rate movement with a 12-month maturity on deposits and loans showed that the weighted average deposit rate in KHR decreased by 0.09% and deposit in US Dollar decreased by 0.01%. At the same time, the weighted average lending rate in KHR increased by 0.04% while lending rate in US dollar decreased by 0.37%.

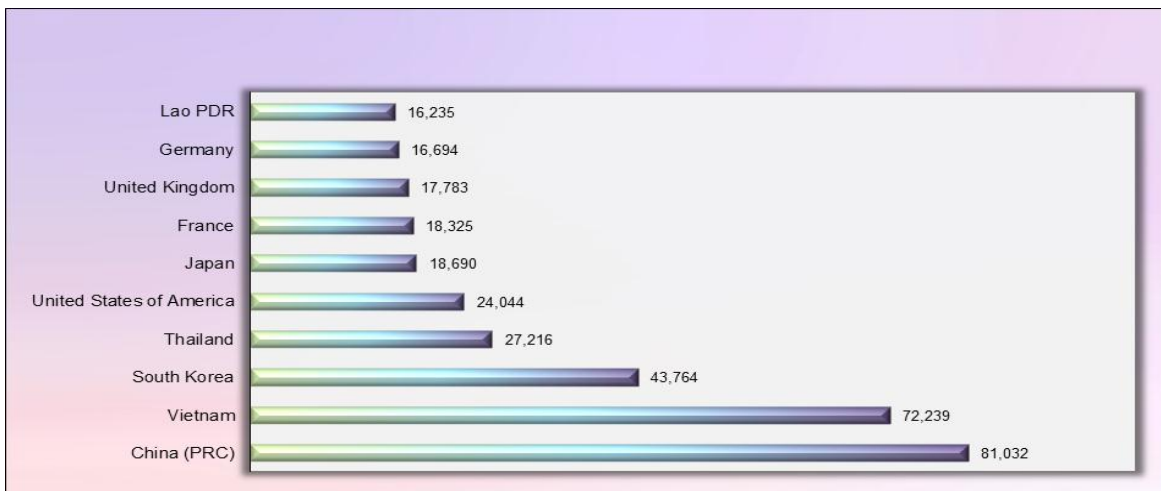


Foreign Tourist Arrivals

In February 2016, the total number of passenger arrivals was 448,468 passengers; declined by 3.8% following the decrease of 18.9% in the preceding month. The main purpose of the passenger arrivals in Cambodia was for vacation, accounting for more than 88% of the total.



Most of the foreign passengers were from China P.R.C., Vietnam, South Korea, Thailand, United States of America, Japan, France, United Kingdom, Germany, and Lao PDR.



International Trade in Goods

International trade in goods showed a deficit of KHR 109.6 billion (4%) in February 2016, from the deficit of KHR 786.3 billion (21.2%) in January 2016.



The major components of total exports were Garment, Footwear, Rubber, and Textile. And the major components of total imports were Petroleum, Vehicles, Motor Bikes, Cigarettes, Construction Materials, Steel, Beer, Cement, Clothing, Gold, and Sugar.

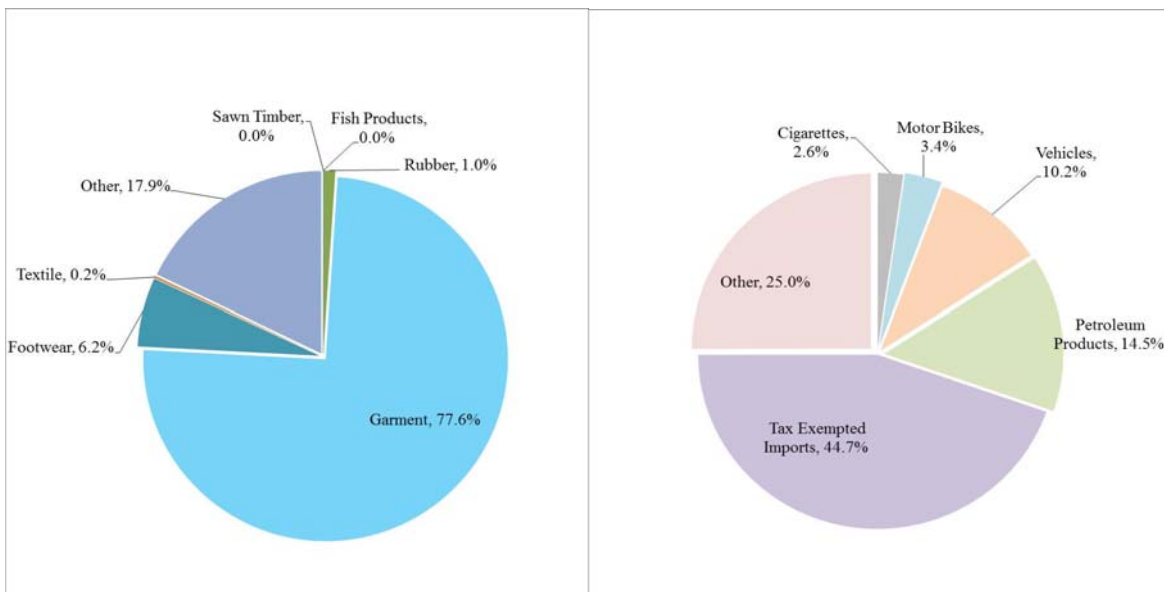

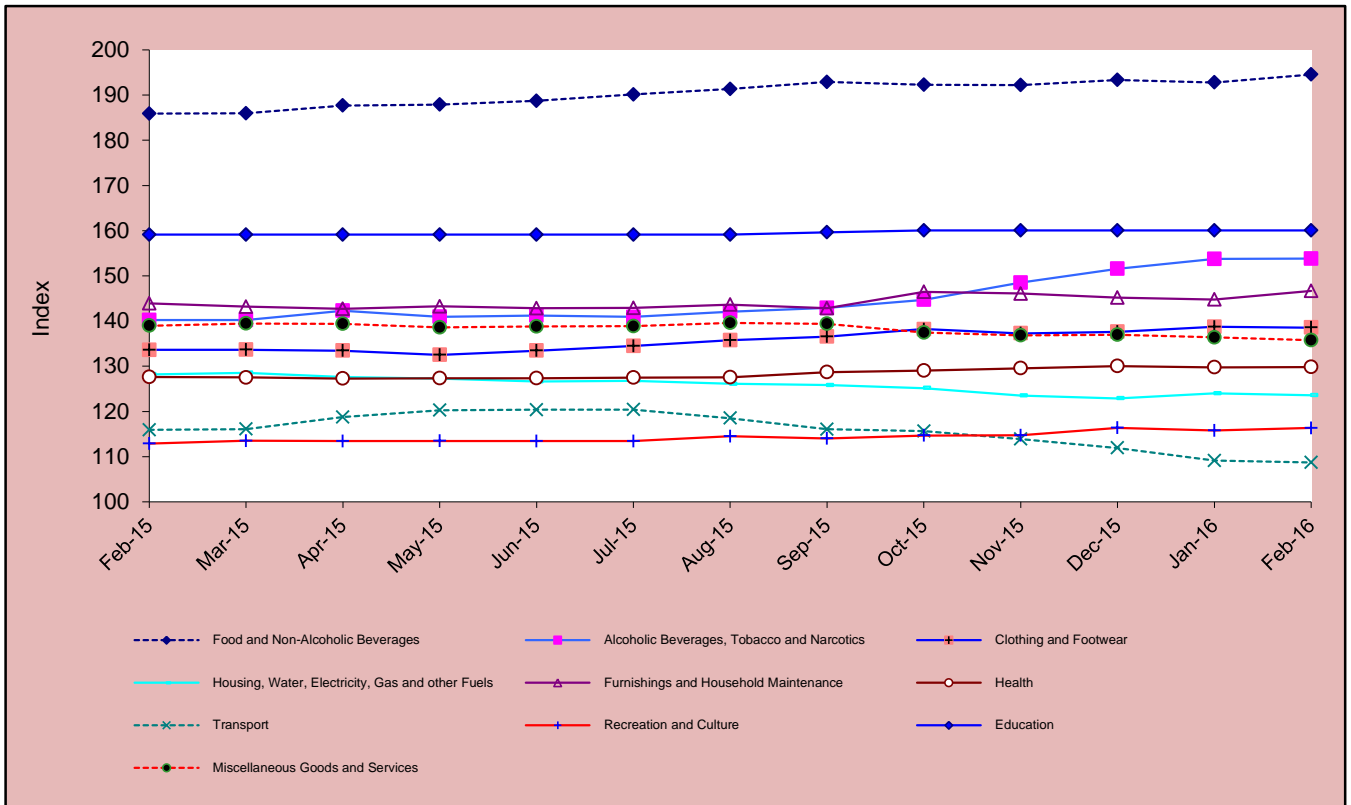

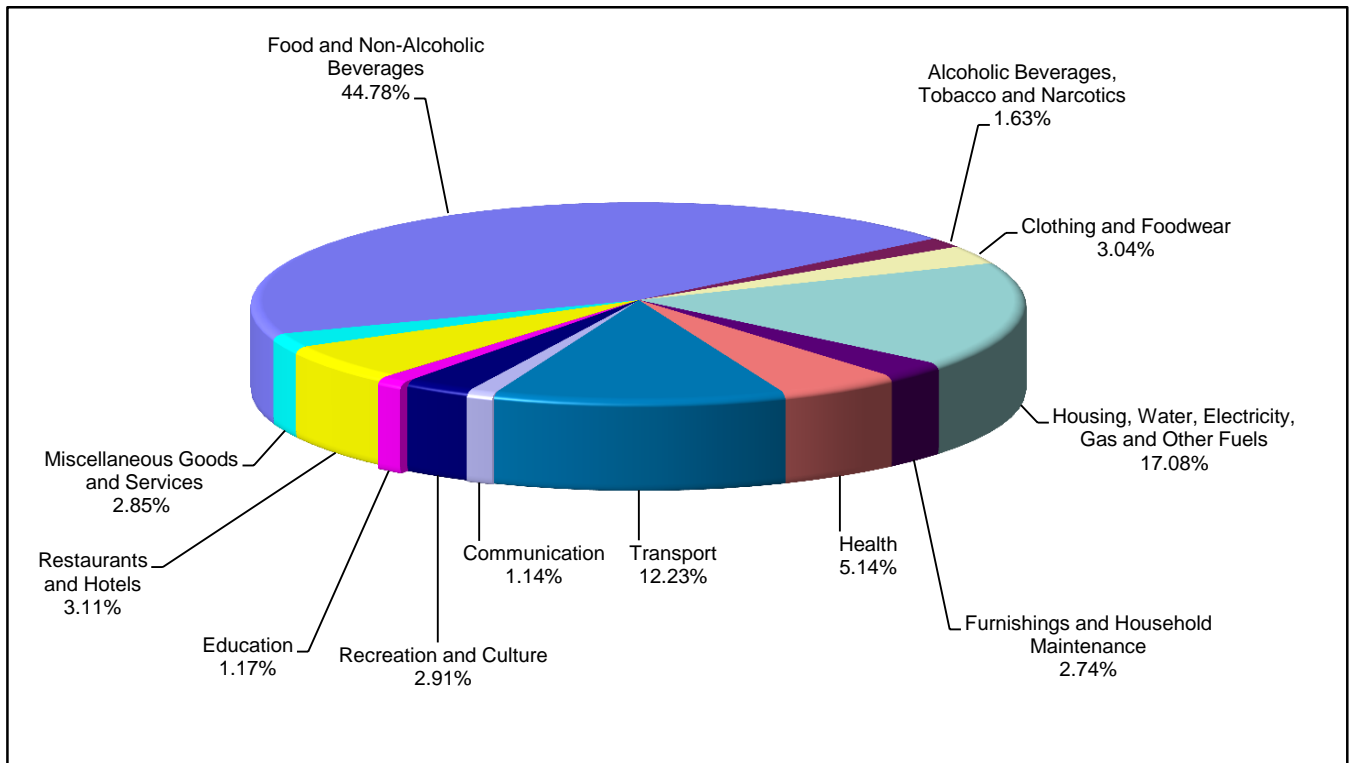

(At Constant 2000 Prices)

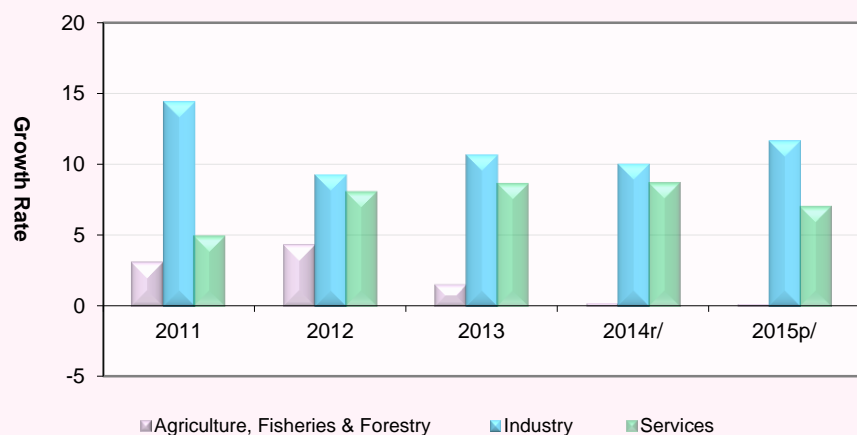
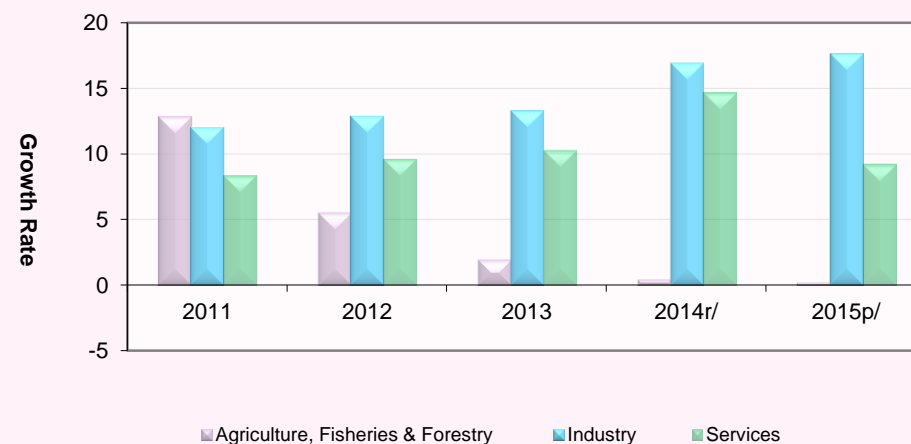


Chart 4: **GDP by Economic Activity**

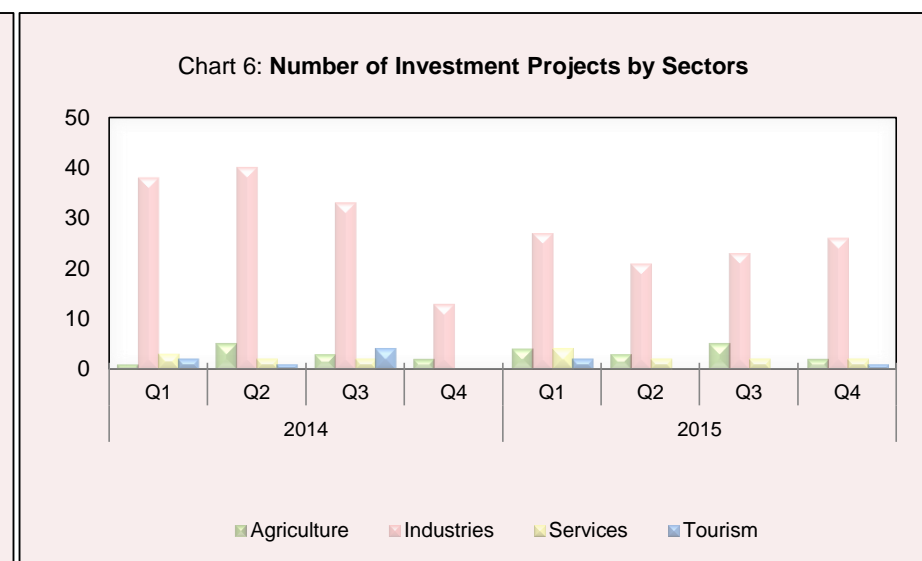
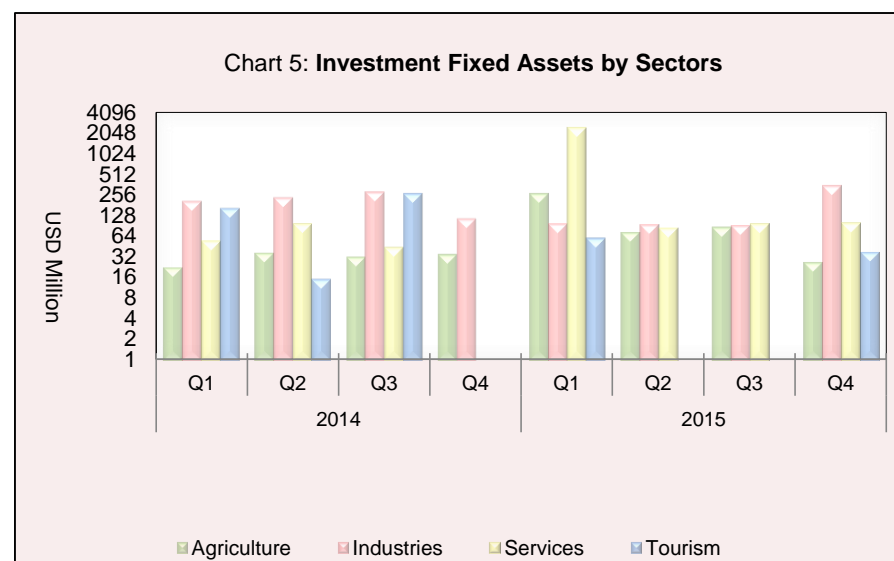

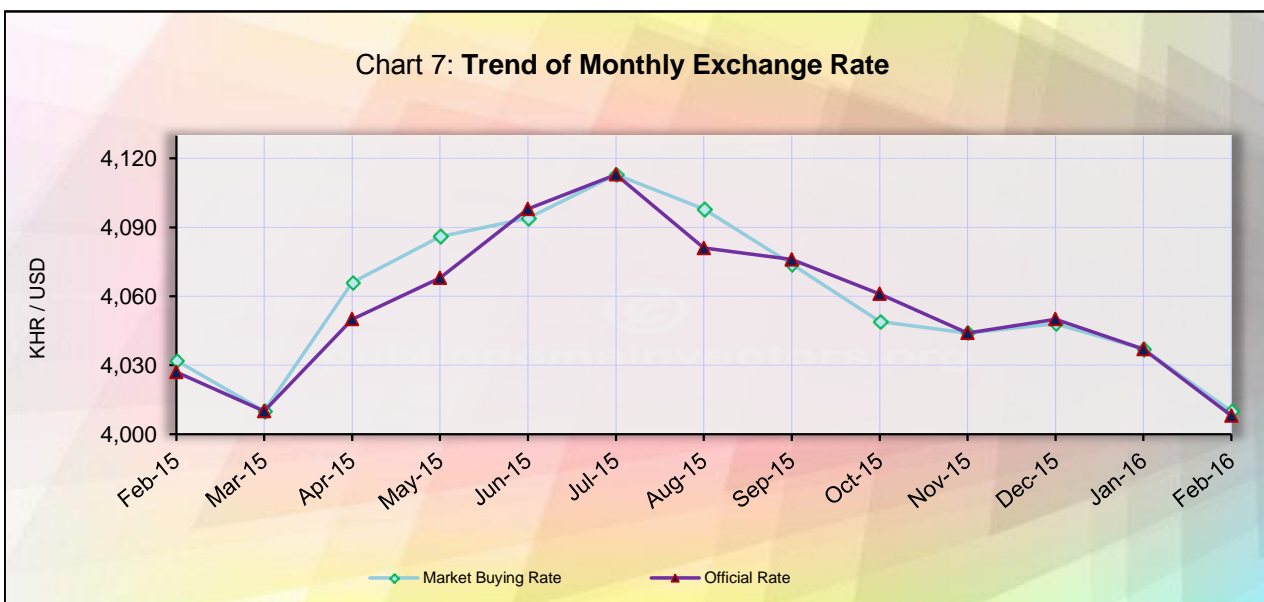

Chart 8: Monetary Survey

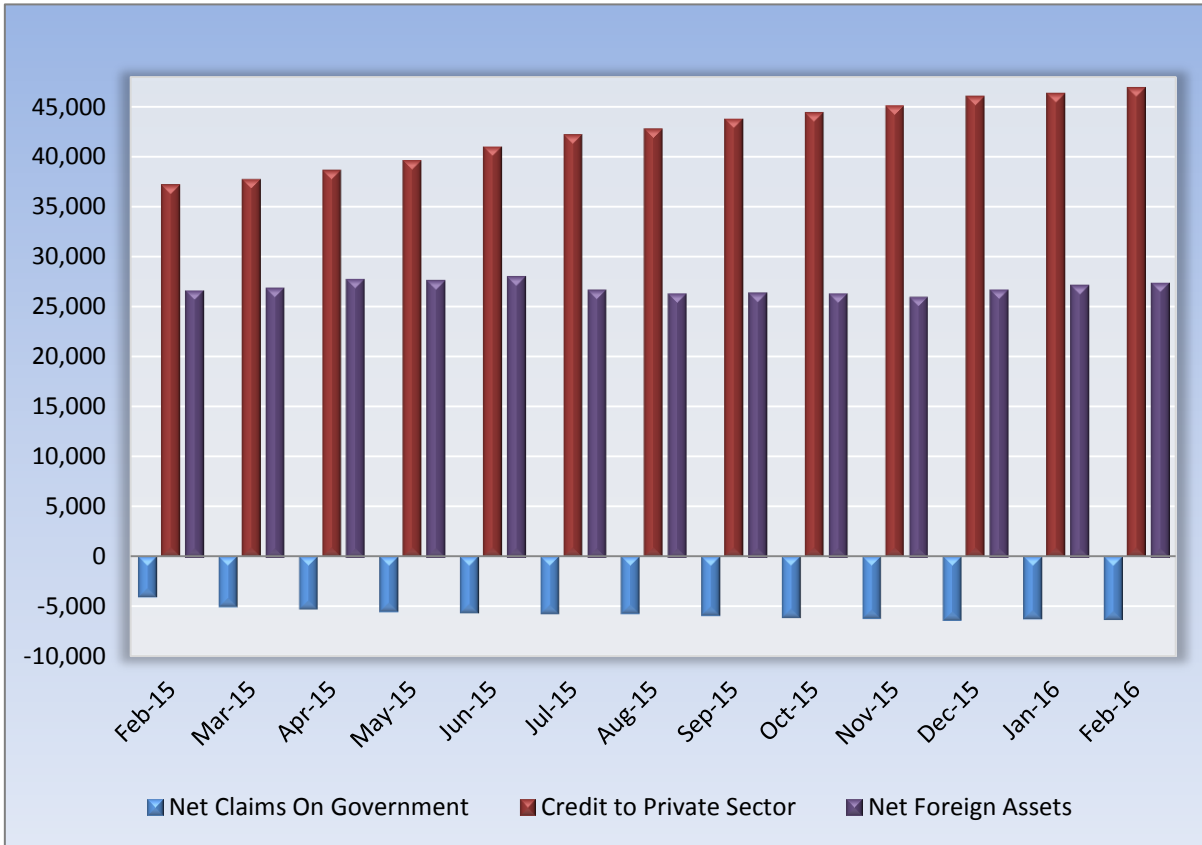


Chart 9: Components of Money Supply

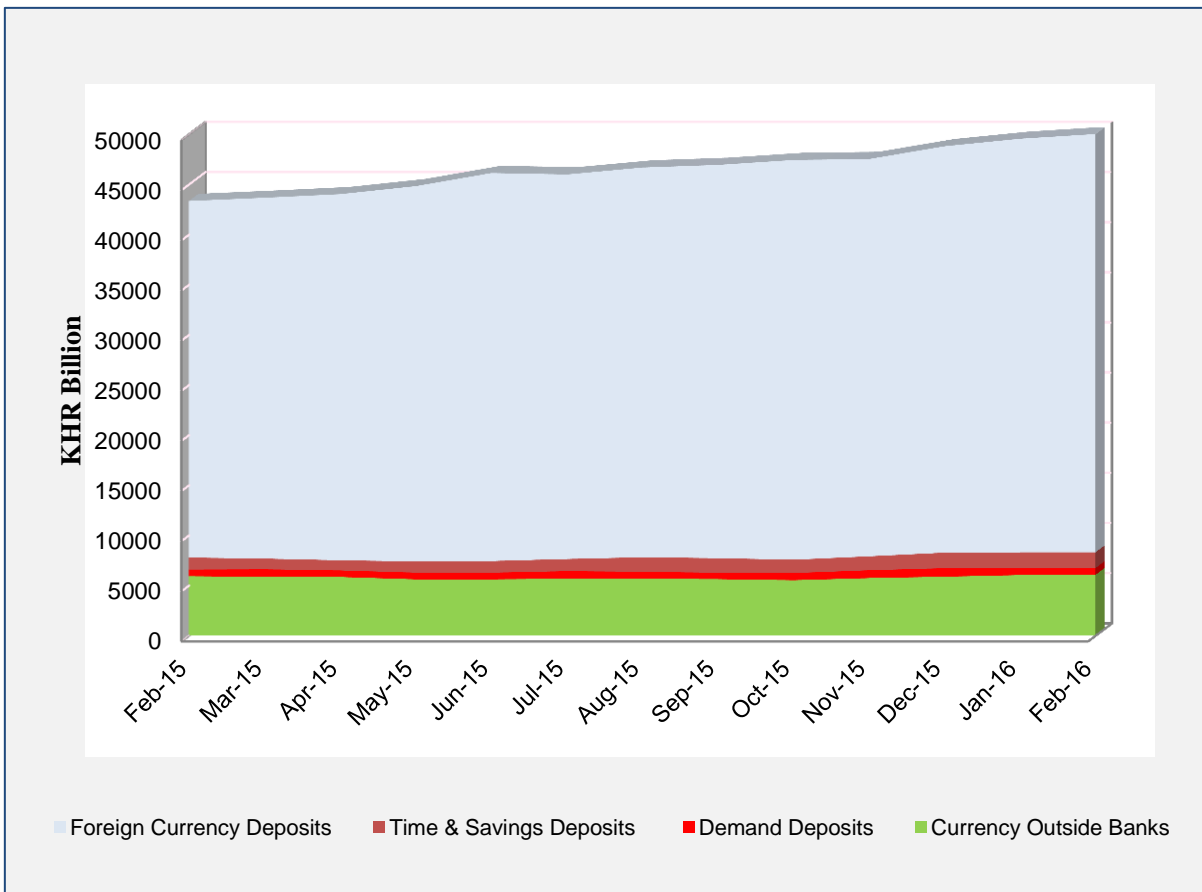

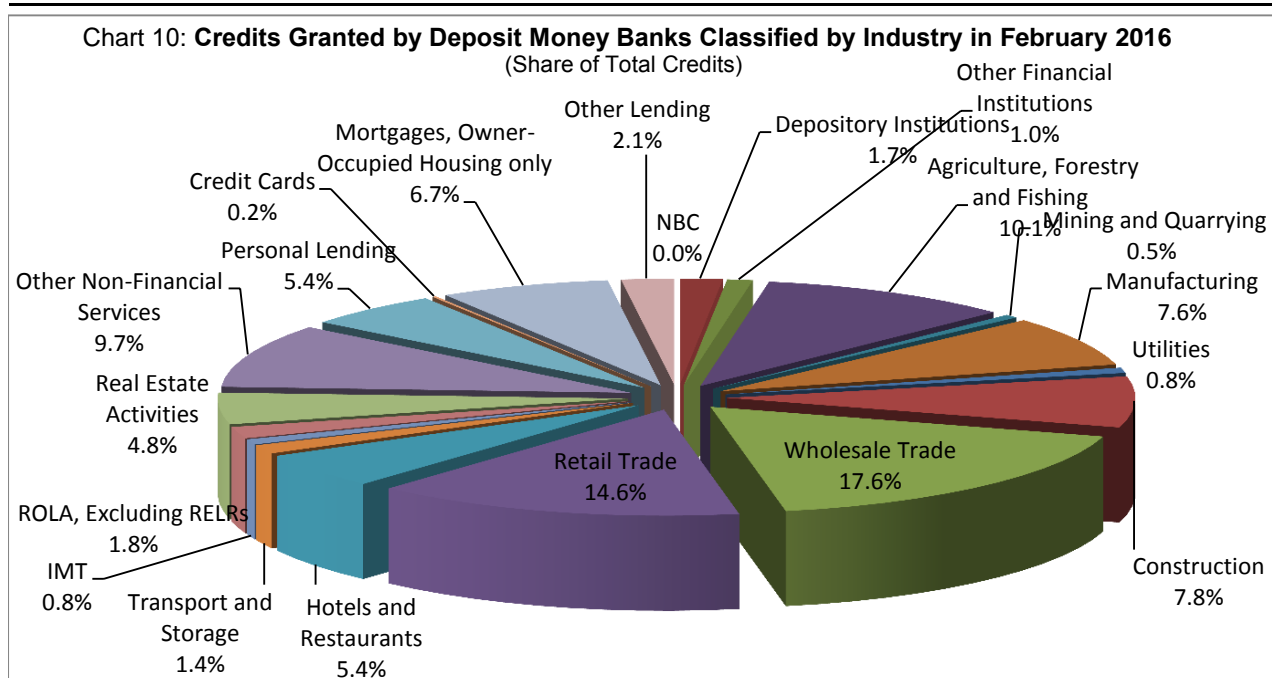

(Share of Grand Total Deposits)

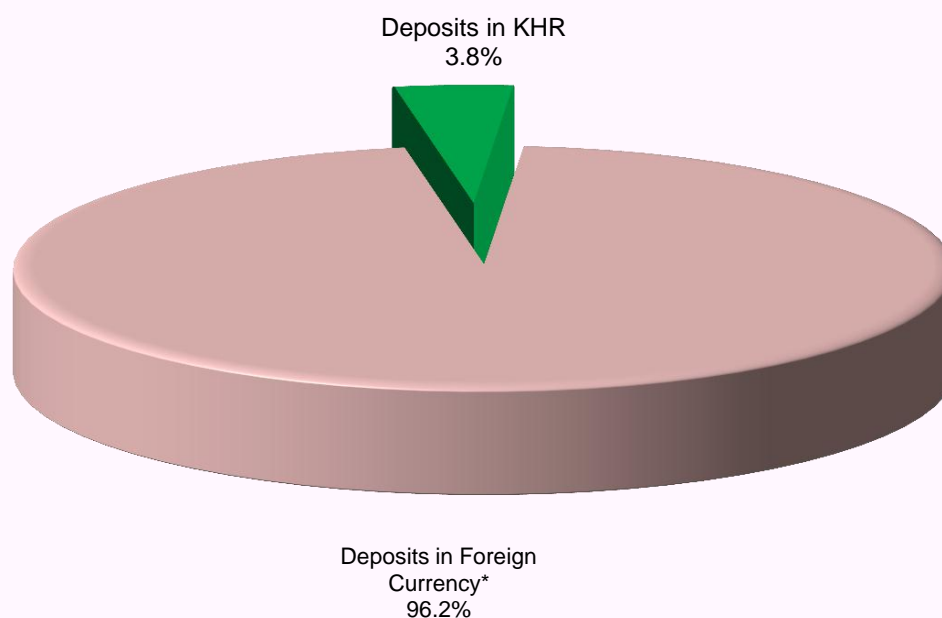

(Share of Total KHR Deposits)

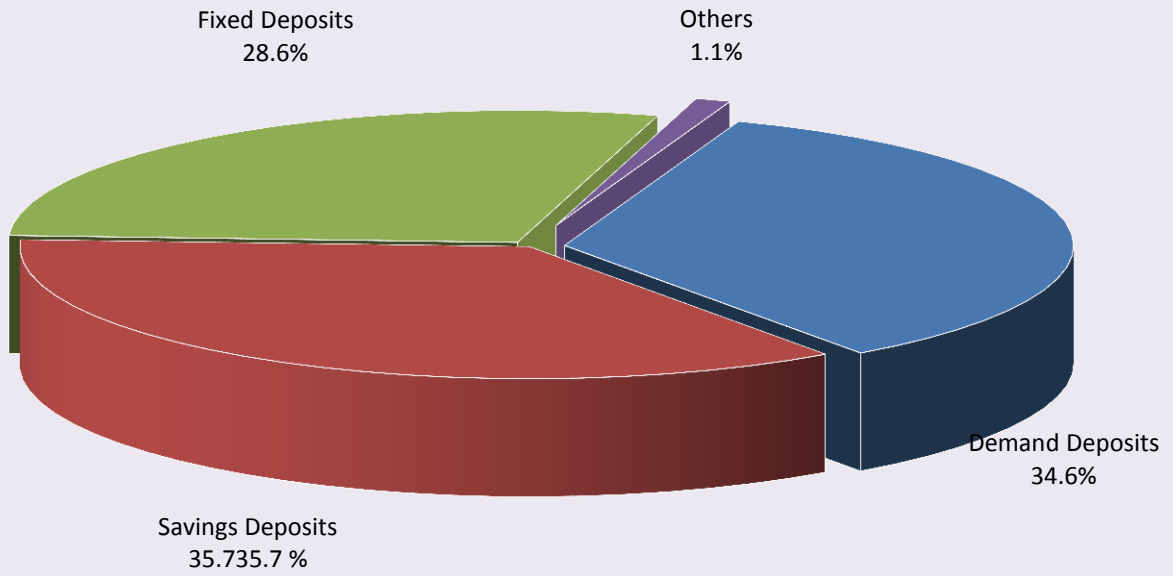
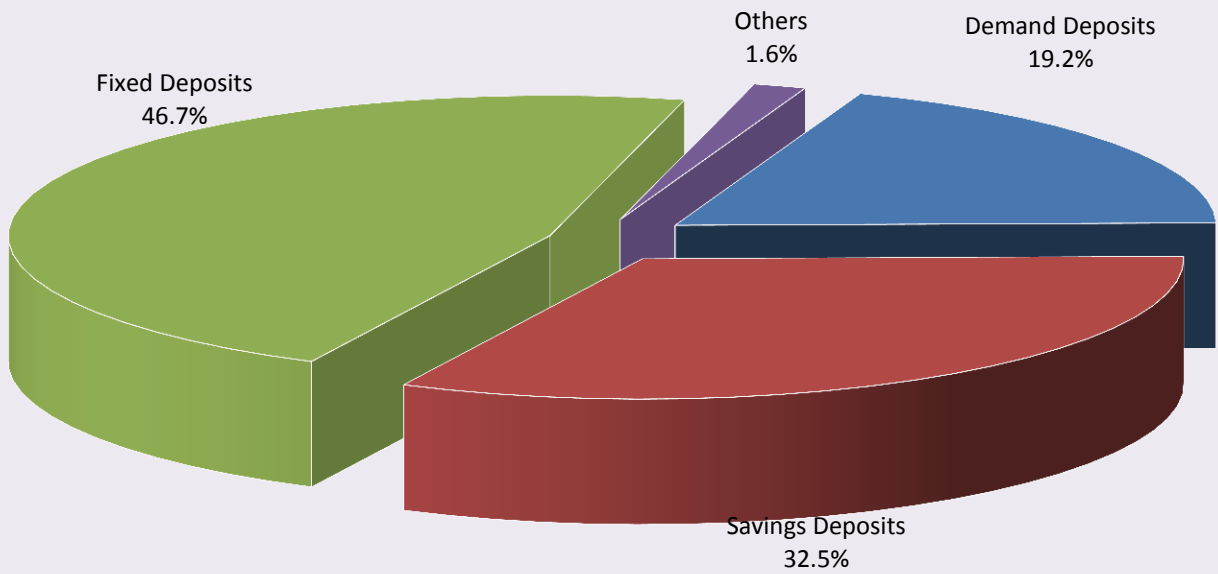


Chart 13: Deposits in Foreign Currency Classified by Type, as of February 2016
